On May 22, 2015, East Cheyenne Gas Storage, LLC ("East Cheyenne" or "Applicant") filed a verified application pursuant to §34-60-116 and §34-60-118, C.R.S., for an order to:

1) Approve the Unit Agreement and plan for unit operations for the approximate 617.665-acre unit (the Lewis Creek Dakota J Unit II) for the Application Lands, for the purpose of an enhanced oil recovery project, and the unitized operations and development from the "J" Sand Formation.

- On October 31, 1958, the Commission entered Order No. 23-2 which approved a
 Unitization Agreement for the "J" Sand Reservoir Unit Area, which provided for the
 unit development and operation of the "J" Sand Reservoir, including repressuring
 water flood operations and a secondary recovery program by the injection of water in
 the "J" sand reservoir.
- On January 13, 1959, the Commission entered Order No. 23-3 which amended the locations of the five water injection wells.
- On June 26, 1962, the Commission entered Order No. 23-4 which amended Order Nos. 23-2 and 23-3 to authorize the injection of water into any zone of the "J" Sand in such quantities and through such wells as shall reasonably be determined to achieve maximum recovery of oil.

 On October 28, 2014, the Commission entered Order 23-5 which, among other things, established an approximate 617.665-acre unit (the Lewis Creek Dakota J Unit II) for the Application Lands, subject to the approval by the Commission of the Unit Agreement, for the purpose of an enhanced oil recovery project, and the unitized operations and development from the "J" Sand Formation.
