NOTICE AND APPLICATION FOR HEARING

TO ALL INTERESTED PARTIES AND TO WHOM IT MAY CONCERN:

Pursuant to Rule 522.e.(2), the Colorado Oil and Gas Conservation Commission ("Commission" or "COGCC") Staff will apply to the Commission at its September 14 and 15, 2015 hearing for an Order Finding Violation ("OFV") against Magpie Operating, Inc. ("Magpie") (Operator No. 52530). This Notice and Application is being served to adjudicate the allegations made in the below-described Notices of Alleged Violation ("NOAV"), the allegations of which are incorporated herein.

Magpie is the operator of record of the following wells:

- a. Little Beaver Unit 53 (API No. 05-121-06178), Washington County, Colorado;
- b. Proctor-Skaer 1-A (API No. 05-069-06159), Larimer County, Colorado;
- c. Fahk-Garrett 3 (API No. 05-001-06011), Adams County, Colorado; and
- d. Safranek-State 2-30 (API No. 05-073-06189), Lincoln County, Colorado.

On April 2, 2015, COGCC Staff issued NOAVs to Magpie for the Little Beaver Unit 53 (NOAV No. 200428452), Proctor-Skaer 1-A (NOAV No. 200428456), and Fahk-Garrett 3 (NOAV No. 200428457) for violations of COGCC Rules of Practice and Procedure, 2 CCR 404-1 ("Rule" or "Rules") 326.b.

On April 19, 2013, COGCC Staff inspected the Safranek-State 2-30 Well and observed violations of COGCC Rules. These violations were not corrected within the time frames set forth in the inspection reports.

On December 3, 2014, COGCC Staff issued NOAV No. 200418517 to Magpie for violations of the following Rules at the Safranek-State 2-30 Well:

- a. Rule 210.d. (Signs and Markers);
- b. Rule 326 (Mechanical Integrity Testing);
- c. Rule 603.f. (Waste, Trash, Debris, and Unused Equipment);
- d. Rule 605.a. (Oil and Gas Facilities);
- e. Rule 1002.f. (Stormwater Management); and
- f. Rule 1003.a. (Interim Reclamation).

COGCC Staff requests that Magpie be found in violation of rules cited above and assessed a penalty pursuant to Rule 523, and other relief as authorized by law.

Anyone who files a protest or intervention must be able to participate in a prehearing conference during the week of August 31, 2015.
