NOTICE AND APPLICATION FOR HEARING

TO ALL INTERESTED PARTIES AND TO WHOM IT MAY CONCERN:

Pursuant to Rule 522.e.(2)(B), the Colorado Oil and Gas Conservation Commission ("Commission" or "COGCC") Staff will apply to the Commission at its September 14-15 hearing for an Order Finding Violation ("OFV") against Fram Operating LLC ("Fram") (Operator No. 10310). This Notice and Application is being served to adjudicate the allegations made in the below-described Notice of Alleged Violation ("NOAV"), the allegations of which are incorporated herein.

Fram is the operator of the Hamilton 32-1 Well (API No. 05-029-06097) ("Well") located in Delta County, Colorado. The well has been shut-in since 2006 and Mechanical Integrity Test ("MIT") was not performed within two years of the well being shut-in. On August 20, 2013 Commission Staff issued a Warning Letter to Fram requiring that it either perform an MIT or plug and abandon the Well by November 20, 2013. Fram failed to comply with this Warning Letter by November 20, 2013.

On June 10, 2015, Commission Staff issued a Notice of Alleged Violation ("NOAV") (No. 2618135) to Fram for violation of the following COGCC Rules of Practice and Procedure, 2 CCR 404-1 ("Rule" or "Rules"):

a. 326.b. (All Shut-In Wells Shall Pass A Mechanical Integrity Test)

COGCC staff requests that Fram Operating Company be found in violation of the rule cited above and assessed a penalty pursuant to Rule 523.

NOTICE IS HEREBY GIVEN, pursuant to: 1) the general jurisdiction granted to the Oil and Gas Conservation Commission of the State of Colorado (Commission) under § 34-60-105 C.R.S.; 2) specific powers granted pursuant to § 34-60-106 C.R.S.; 3) the Colorado Administrative Procedures Act at § 24-4-105 C.R.S.; and 4) the Commission's Series 500 Rules at 2CCR 404-1, that the Commission has scheduled the above-entitled matter for hearing on:

One electronic, one original and two copies shall be filed with the Commission. Anyone who files a protest or intervention must be able to participate in a prehearing conference during the week of August 31, 2015.
