## NOTICE OF HEARING

#### **APPLICATION**

On July 16, 2015, ConocoPhillips Company ("ConocoPhillips" or "Applicant") filed a verified application pursuant to §34-60-116, C.R.S., for an order to:

- 1) Vacate Order No. 535-97 as it applies to Section 15 of the Application Lands;
- 2) Establish an approximate 1280-acre drilling and spacing unit for the Application Lands, for the production of oil, gas and associated hydrocarbons from the Niobrara Formation;
  - 3) Approve up to two (2) horizontal wells within the unit; and
- 4) Require the productive interval of the wellbore to be located no closer than 460 feet from the unit boundaries, and no closer than 150 feet from the productive interval of any other wellbore located in the unit, without exception granted by the Director.

### APPLICABLE RULES AND ORDERS

- Rule 318.a. of the Rules and Regulations of the Oil and Gas Conservation Commission requires that, on unspaced lands, wells drilled in excess of 2,500 feet in depth be located not less than 600 feet from any lease line, and located not less than 1,200 feet from any other producible or drilling oil or gas well when drilling to the same common source of supply.
- On October 31, 2011, the Commission entered Order No. 535-97, which among other things, approves the request for an order establishing 30 approximate 640-acre drilling and spacing units for lands in Townships 4 and 5 South, Ranges 64 and 65 West, 6<sup>th</sup>

P.M., for the production of oil, gas, and associated hydrocarbons from the Niobrara Formation.
