CONT. (7/24/06) THE PEOPLE ATTENDING THE MEETING WERE MARCIA DASKO, TRACY DAHL, MRS. GOPA-ROSS, TOM GLIBUTA, VINCE VIGIL AND I. THE GROUP VOICED THEIR CONCERNS AND SAID THE DRILLING OF THE MOLOKAI WELL WAS RESPONSIBLE FOR THE DELORUS WATER WELL TURNING INTO A GEYSER. MRS. GOPA-ROSS GAVE VINCE AND I PHOTOS AND SAID THAT THE DRILLING CREW FOR PIONEER DID NOT PUT SURFACE CASING IN THE MOLOKAI WELL. I TOLD THE GROUP THAT VINCE AND I WOULD CHECK IT OUT. WE LEFT AT 11:00 AM. I PARKED MY JEEP IN WESTON AND VINCE AND I DROVE UP WET CANYON TO THE MOLOKAI WELL. UPON ARRIVAL AT THE WELLSITE, I SAW THAT PENSE BROS. WAS THE DRILLER. I TALKED TO NICK RICHARDSON (DRILLING FOREMAN) AND HIS CREW. I ASKED WHY SURFACE CASING HAD NOT BEEN PUT INTO THE MOLOKAI WELL. THEY GAVE ME THE DRILLING PERMIT AND I NOTED THAT THE SURFACE CASING WAS TO BE SET AT A DEPTH OF 1050 FEET. THEY SAID THEY HAD PROBLEMS AT 355 FEET, AND HAD CONTACTED DAVE DILLON ABOUT PLUGGING PROCEDURES. THEY SKIDDED THE RIG AND HAD DRILLED THE 2ND WELL TO A DEPTH OF 1062 FEET AND CEMENTED IT IN PLACE ON SATURDAY (7/22/06). I TOOK 2 PHOTOS OF THE CEMENTED WELL AND VINCE AND I LEFT WELLSITE AT 12:30 PM. WHEN I GOT BACK TO TRINIDAD, I MADE COPIES OF THE PHOTOS MRS. GOPA-ROSS HAD GIVEN VINCE AND I. I MAILED THE PHOTO COPIES TO DAVE SHELTON (COGCL), I KEPT A SET FOR MYSELF AND GAVE THE ORIGINALS TO BOB LUCERO.
