All,

Mike Gardner and I spoke at about 3:45 pm regarding the discovery of another dead elk calf by Ned Prather. Ned had called both myself and Mike about 90 minutes earlier to report the discovery of the animal in the vicinity of Spring No. 2. I have left messages for Dean Riggs (CDOW Area Wildlife Manager) and J.T. Rommartzke (CDOW District Wildlife Manager) regarding the discovery. While I was chasing them (and also talking with Ned), Mike Gardner made arrangements to meet Ty Smith (the CDOW person who was carrying their emergency phone this afternoon) and guide him to the carcass.

I asked Mike and Ty to photograph the carcass and get GPS coordinates for the location. I will speak with Dean Riggs and Ron Valardi tomorrow morning to be sure the carcass is sent to the appropriate lab for the purpose of determining the cause of death. I will transmit CDOW's findings to Marathon, Williams, Nonsuch, and PDC (and of course the Prathers and Savages) as soon as they are available.

This was the second time this weekend that I've received a "Please Call ASAP" e-mail on my Blackberry and so far that approach is working.
