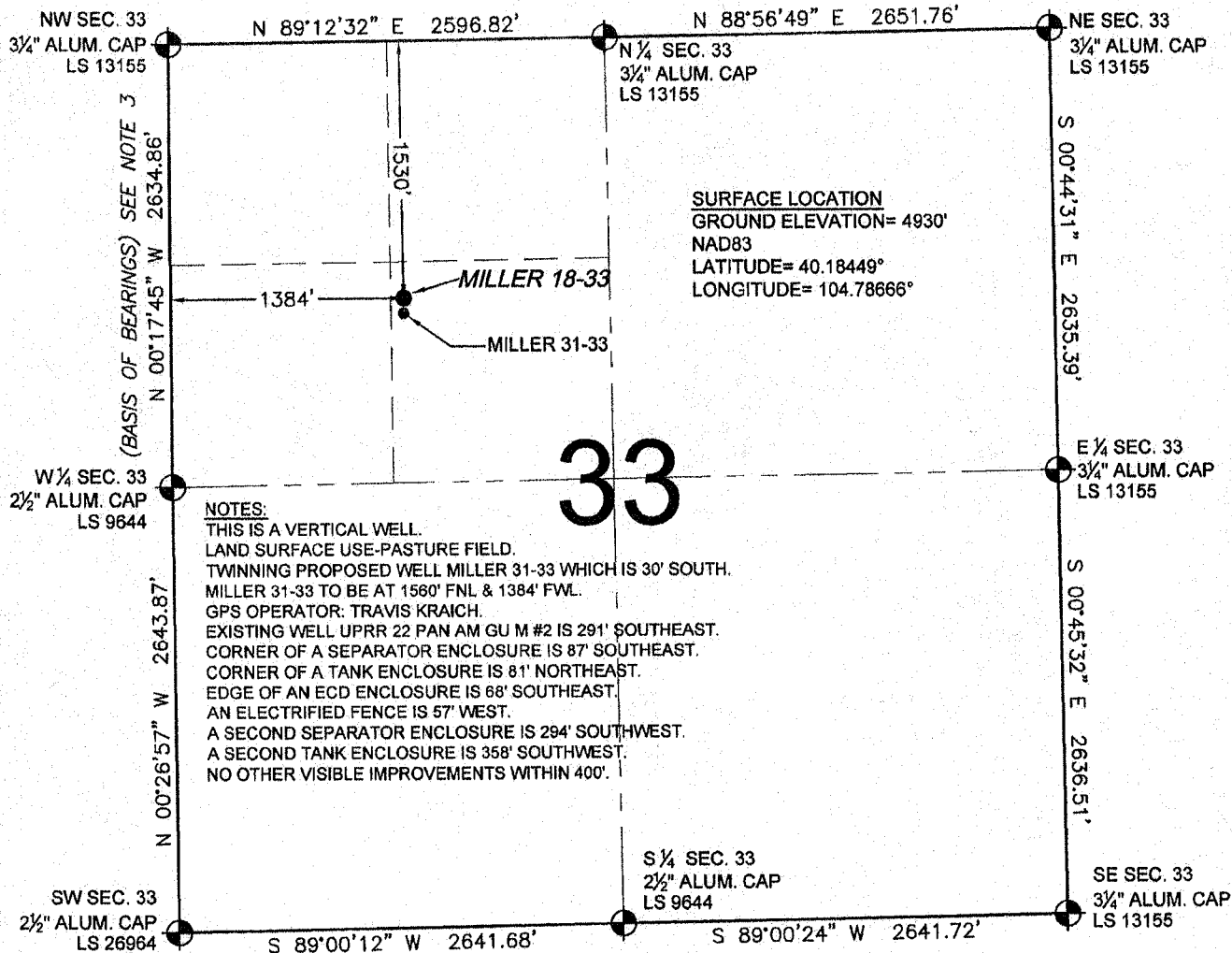


# WELL LOCATION CERTIFICATE: MILLER 18-33

SECTION 33, TOWNSHIP 3 NORTH, RANGE 66 WEST, 6TH P.M.



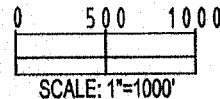

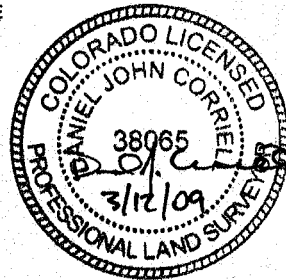


## NOTES:
