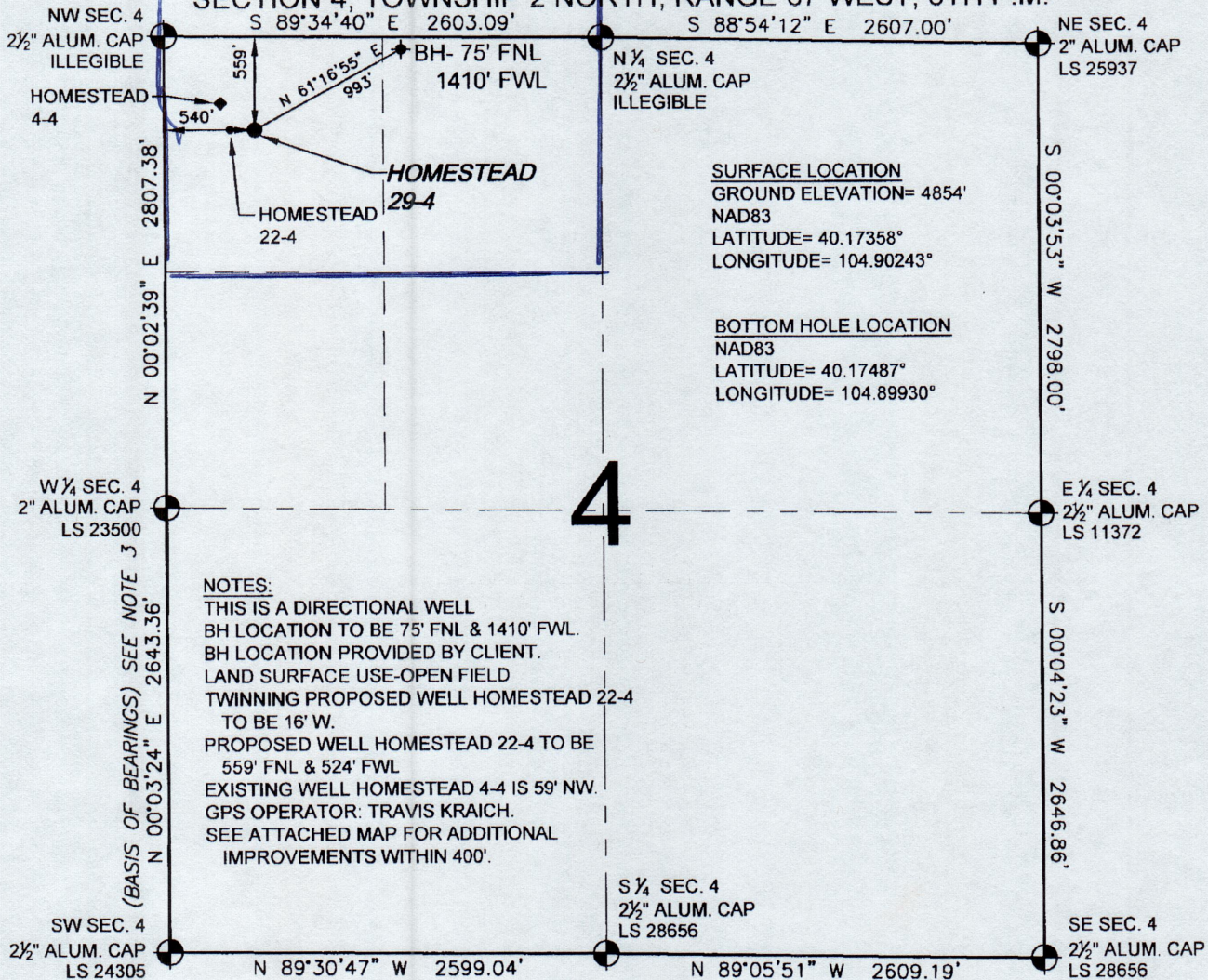

WELL LOCATION CERTIFICATE: HOMESTEAD 29-4

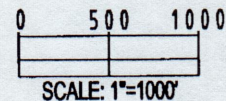
SECTION 4, TOWNSHIP 2 NORTH, RANGE 67 WEST, 6TH P.M.

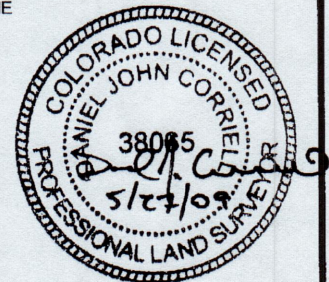

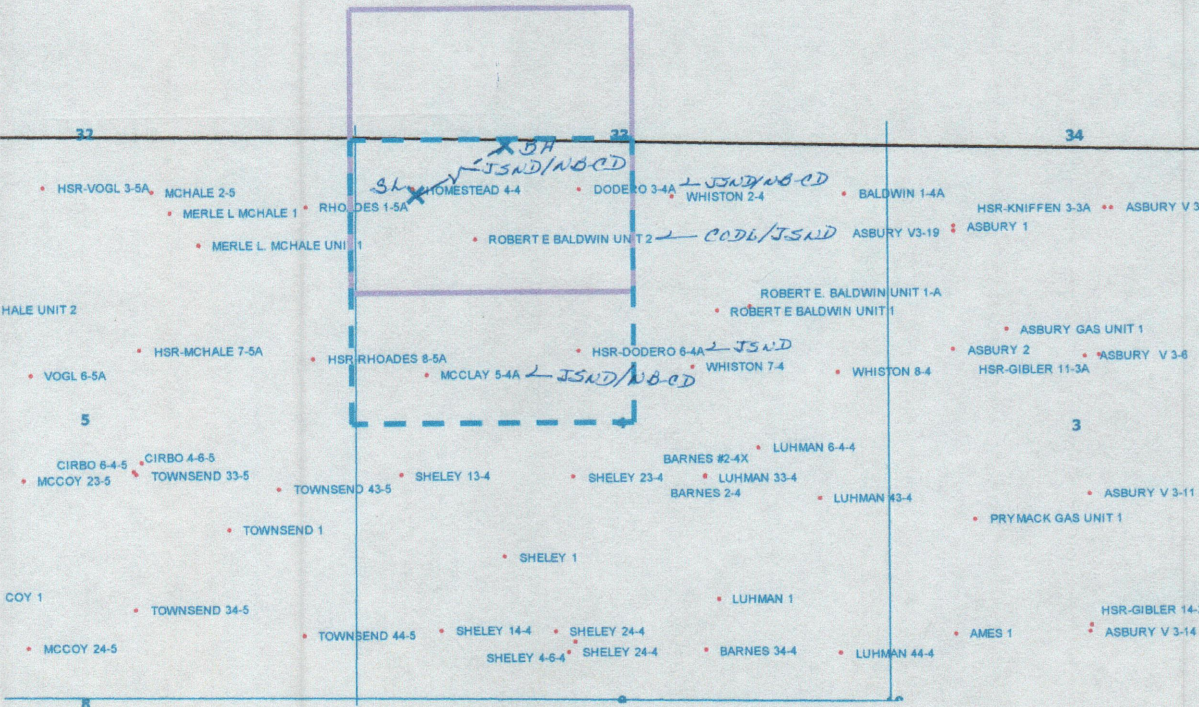
