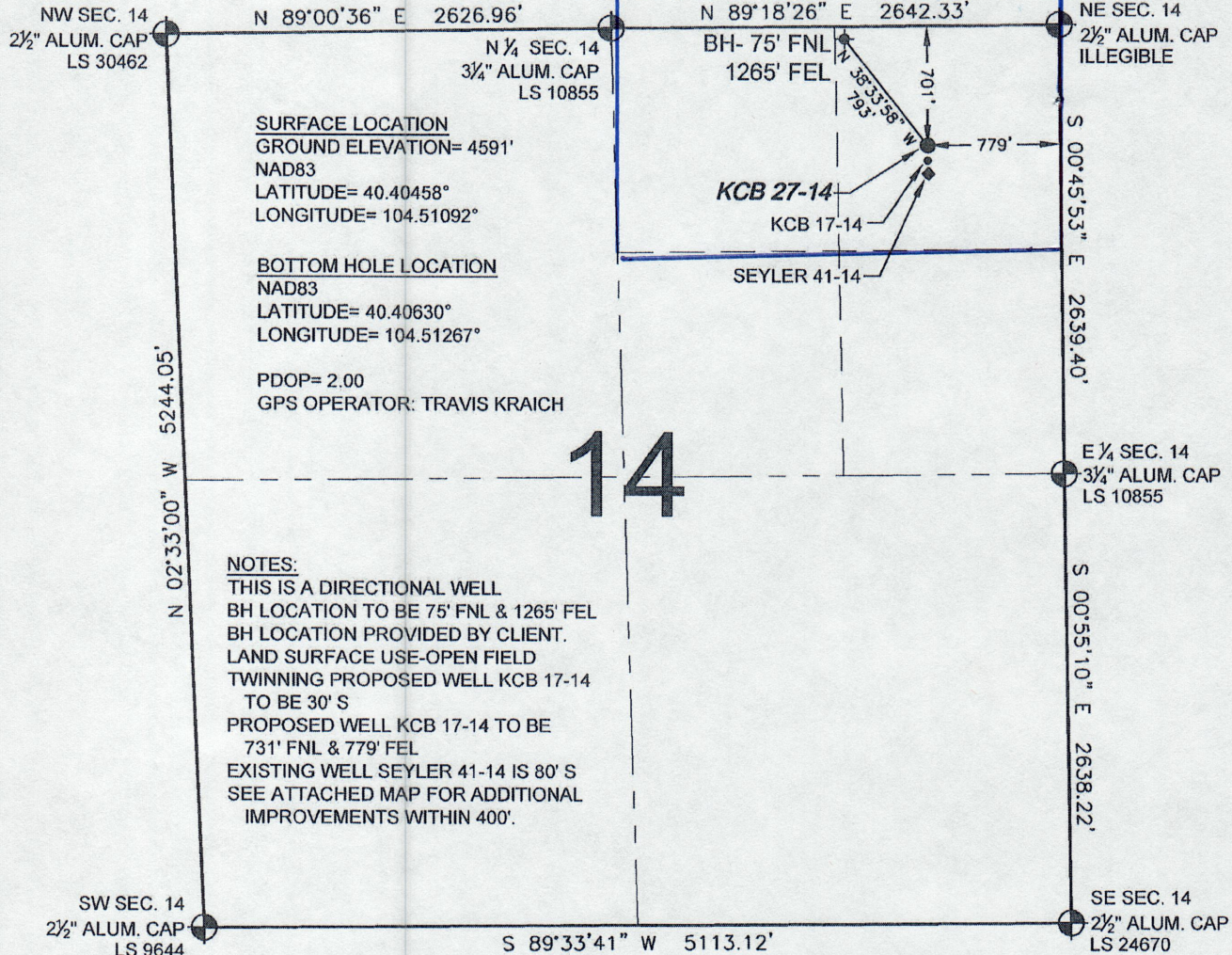

SECTION 14, TOWNSHIP 5 NORTH, RANGE 64 WEST, 6TH P.M.

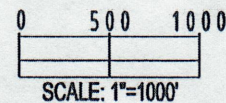

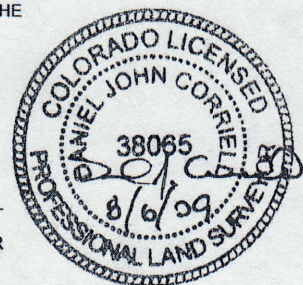

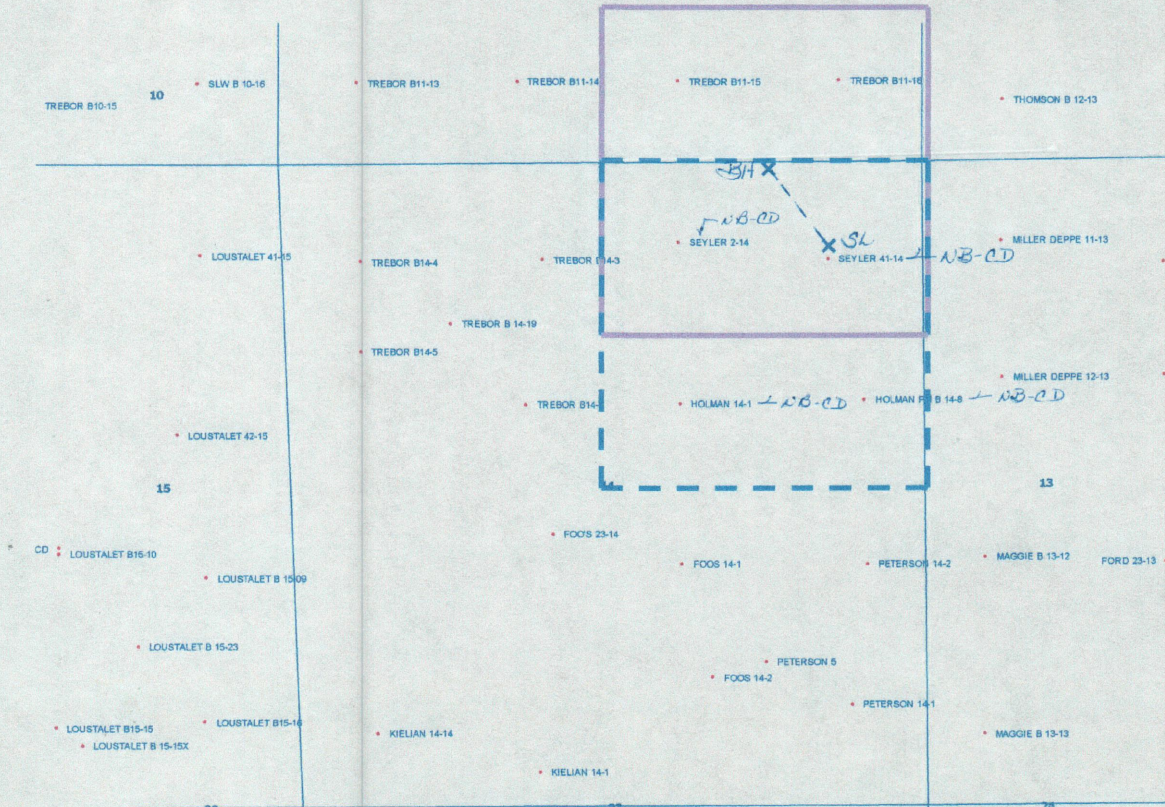
