I apologize for the delay in getting back to you but Jessica actually works for the Executive Director's Office (EDO) and was on loan to COGCC to help with 2A review. Unfortunately she has been recalled back to the EDO for the near future. I will be following up on this Form 2A.

You are correct that water well Permit #222089 is only 176 feet further away than the water well we used (#47198). However, your recommended water well (#222089) is completed in a deeper aquifer and is screened from a depth of 230 to 290 feet. This deeper aquifer does not represent the surficial aquifer conditions. There is also another well even closer (#10578) approximately 3856 feet to the northeast of the proposed location. This shallow well indicates a static water level of 2 feet. Both of the shallow wells (#47198 and #10578) are located within the same topographic contour as the proposed well and provide a reasonable estimate of depth to groundwater. I have attached a sketch map showing the locations of the water wells – I don't have a purchased copy of ADOBE so I just roughed out a WORD document.

Please call me and we can go over any questions or differing points of view. If not please email your approval of designating this as a sensitive area and adding a COA for a lined pit or closed loop system. Take care, Mary
