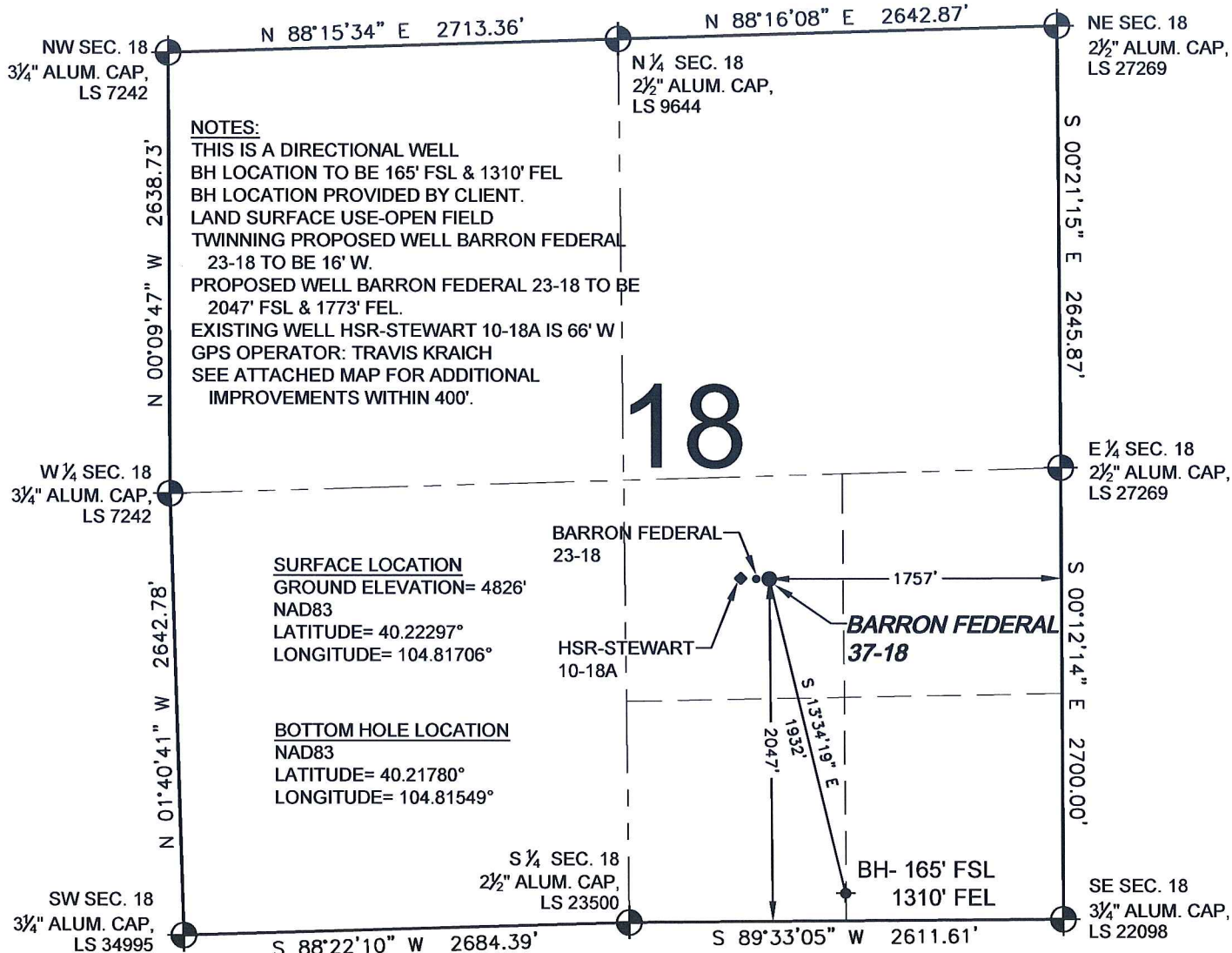


WELL LOCATION CERTIFICATE: BARRON FEDERAL 37-18

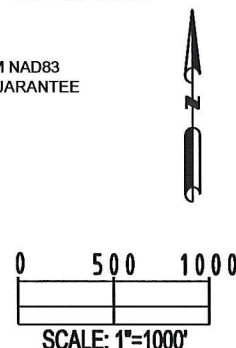
