


King Surveyors Inc. has determined the surface location of the Horse Iron P22-310 to be 2426' from the North line and 975' from the East line and the bottom hole location to be 1206' from the NORTH line and 106' from the EAST line as measured at right angles from the section line of Section 21, Township 3 North, Range 67 West of the Sixth Principal Meridian, County of Weld, State of Colorado. I hereby state that this Well Location Certificate was prepared by me, or under my direct supervision, that the fieldwork was completed on 3-5-09, for and on behalf of Noble Energy Inc. That this is not a Land Survey Plat or an Improvement Survey Plat, and that it is not to be relied upon for establishment of fence, building, or other future improvement lines.




