Miracle,

I have been reviewing the Shideler 25-9C1 (C31E) ( #400002078) **Form 2A**. COGCC requests the following clarifications regarding the data Encana Oil & Gas has submitted on or attached to the Form 2A prior to passing the Oil and Gas Location Assessment.

1. **Location Identification (Section 4):** When I locate this well using the latitude and longitude, I come up with a QuarterQuarter of NENW, not NESE. Can you confirm the latitude and longitude. If they are correct, I can make this QuarterQuarter change if you send me an email with this request.
2. **Construction (Section 6):** Estimated Post-Construction Ground Elevation is blank: based on the Construction Layout Drawing (Sheet 4 of 11), the final grade elevation is 6750. I can make this change if you send me an email with this request.
3. **Water Resources (Section 14):** Form 2A indicates the depth to groundwater to be 185 feet bgs for a well located 7040 feet away from the proposed pad. COGCC's review indicates there is a water well (Permit No. 9041-Cormack, domestic well) located 6864 feet to the east, with a total depth of 85 feet bgs and a depth to groundwater of 60 feet bgs. There is another water well (Permit No. 7393-Deardorff, domestic well) located 7444 feet to the northeast, with a total depth of 76 feet bgs and a depth to groundwater of 40 feet bgs. I could not find another well nearby that had a depth to groundwater of 185 feet bgs. Can you confirm the water well location by direction and permit number, or I can make this change if you send me an email with this request.

These are minor changes and I would like to get this passed. If you have any questions, please do not hesitate to call me at (970) 625-2497 x5 (office) or (970) 309-2514 (cell), or email. Thanks.
