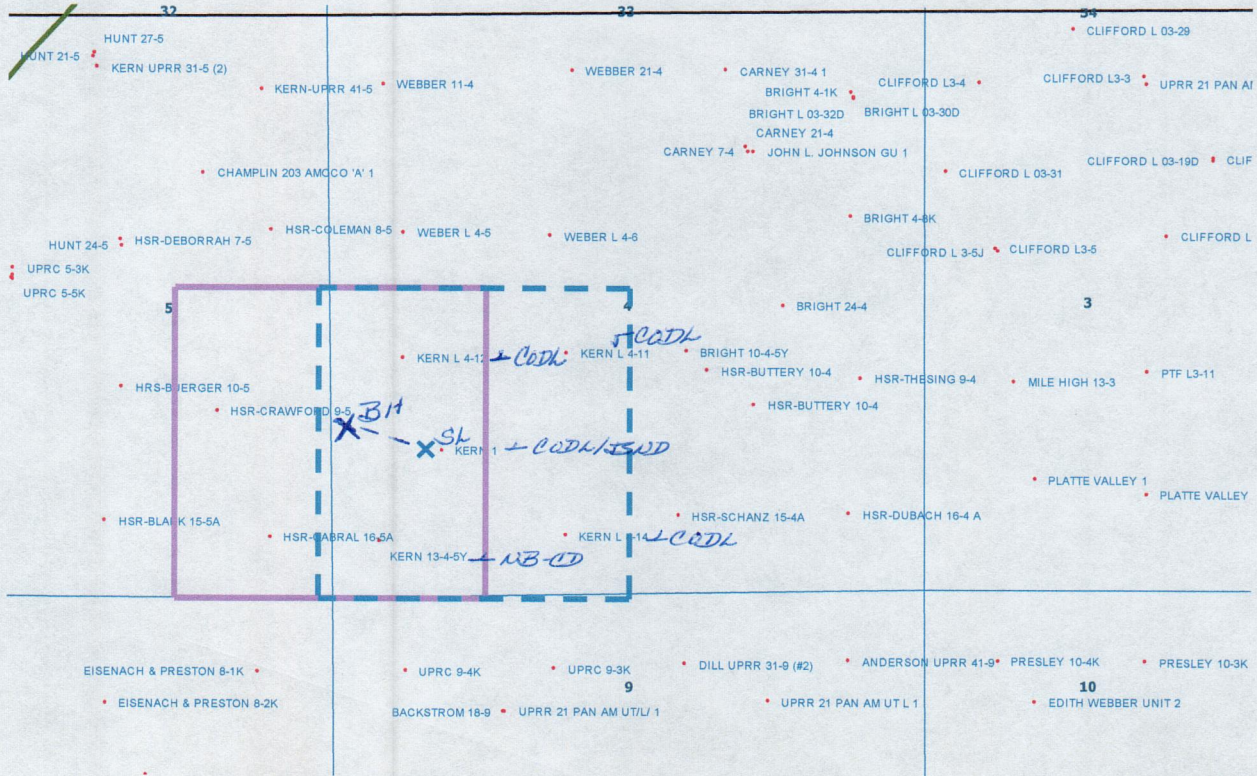

Proposed 160 acre Spacing Unit (Solid line).



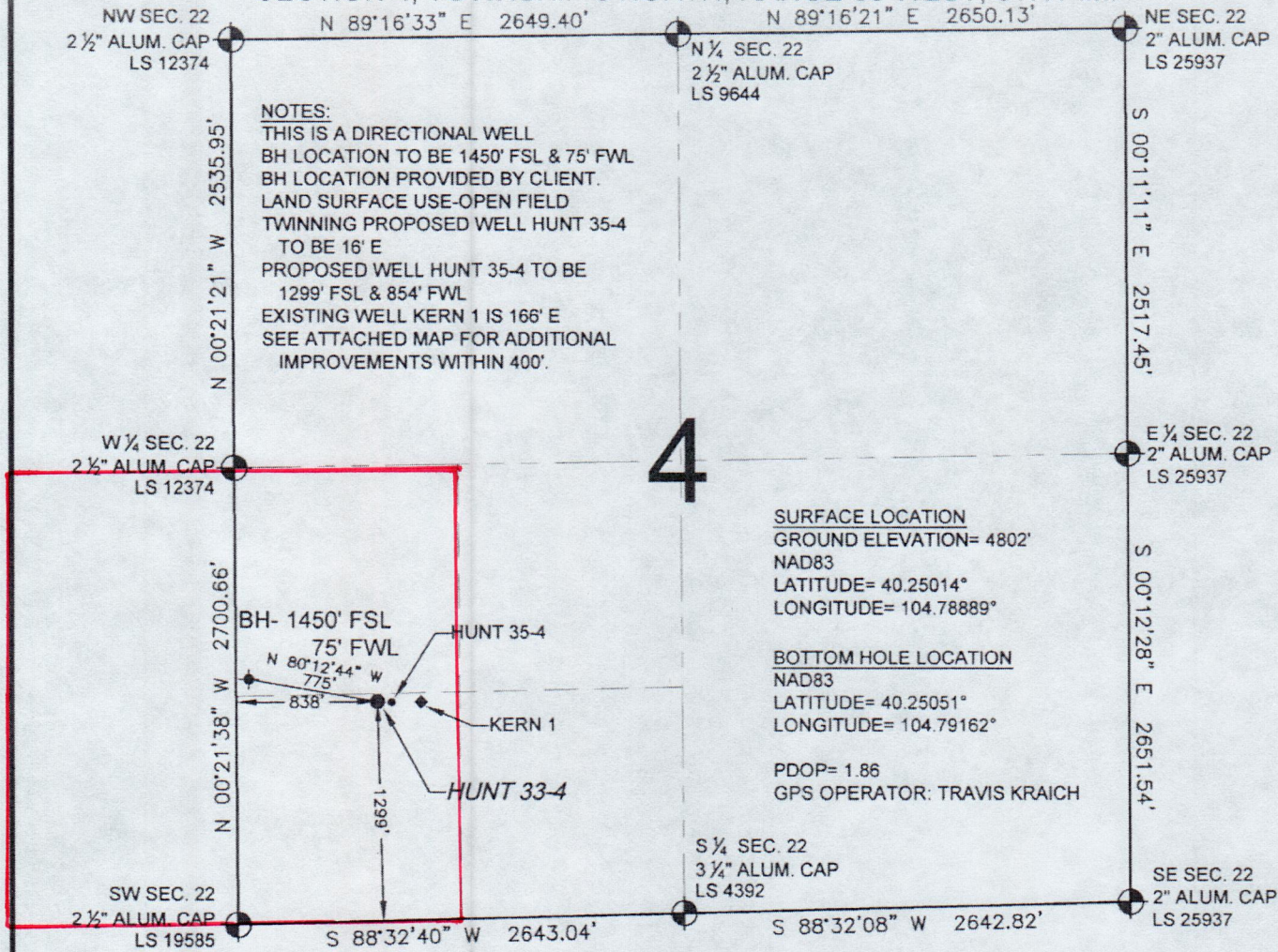
Bottom Hole Located NW/4SW/4, Sec. 4-T3N-R66W (Dashed line).

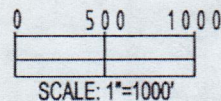

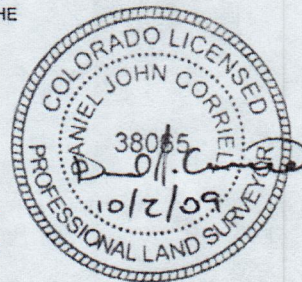
