On rig and during drilling = 2 oil tanks, 1 separator, 77 electric motors, 4 gas or diesel motors, 3 electric generators, 2 fuel tanks, 1 flare, and 1 VOC combuster. After drilling, the location will only contain the 2 well heads and 2 3-phase flowlines which go to a facility approx 1-1/2 miles away.
