

THIS LOCATION HAS ALREADY BEEN BUILT AND CONDUCTORS SET FOR THE ORIGINAL 7K PAD WELLS. IN ORDER TO CONSOLIDATE WELL PADS 7O WITH 7K, THE ABOVE WELL NEEDS TO BE SHIFTED FROM THE (NWSE) TO (NESW). THIS IS A BUREAU OF LAND MANAGEMENT SURFACE (BLM) AND BLM, REBECCA BEAVERS, HAS ALREADY APPROVED CHANGE. THIS CHANGE IS NECESSARY TO KEEP THE SURFACE DAMAGE MINIMAL. THE 7O PAD ALONG WITH THE ADJACENT PIPELINE WOULD NOT HAVE TO BE CONSTRUCTED. NOBLE ENERGY WOULD SET CONDUCTOR, WELD PLATE ON, AND FILE FOR A NEW PERMIT WITH COGCC. THIS WOULD ALLOW NOBLE ENERGY INC. TO BEGIN DRILLING IMMEDIATELY WHEN WINTER STIPS ARE LIFTED 5/1/2009.
