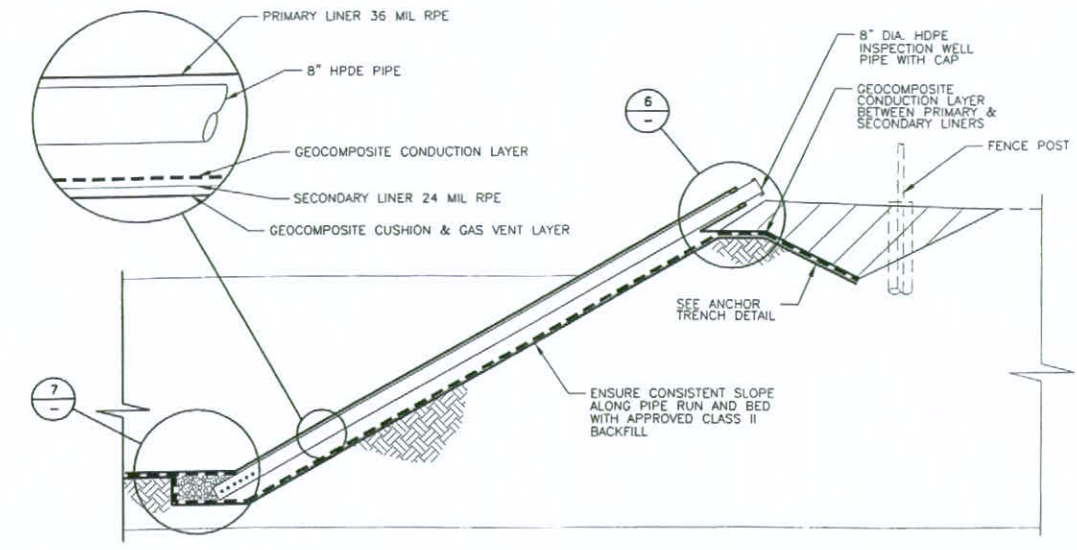

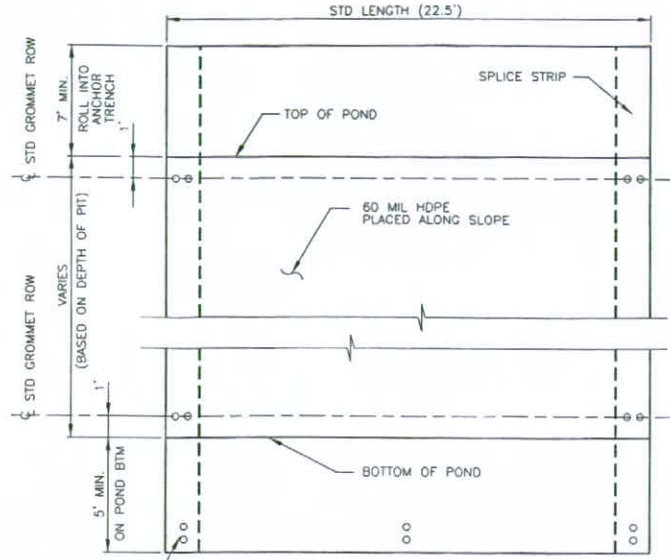
2 TYPICAL POND LINING SYSTEM DETAIL

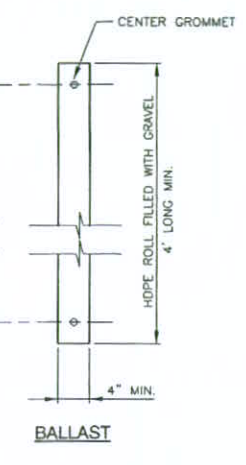

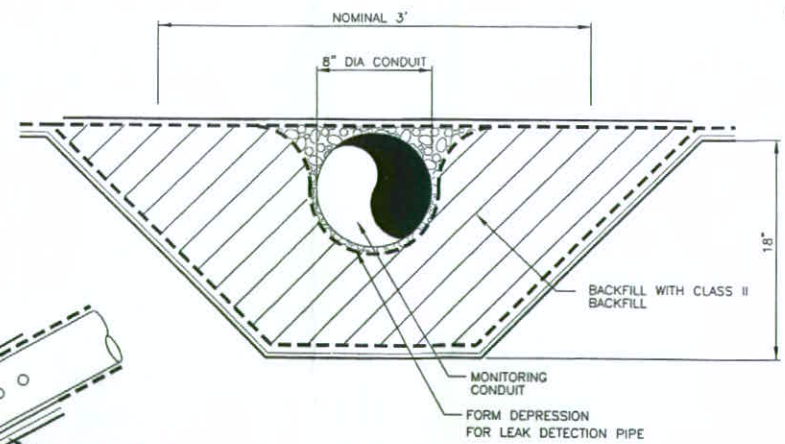

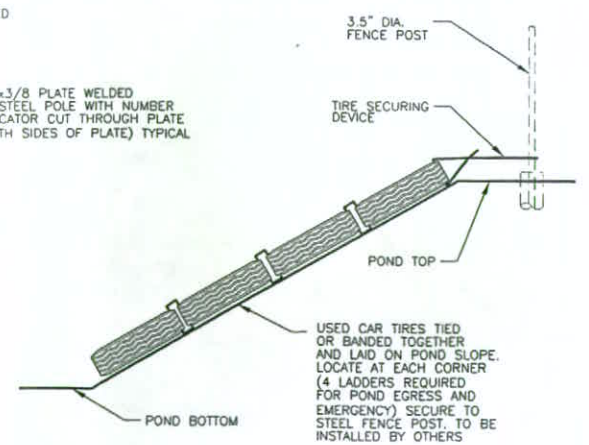

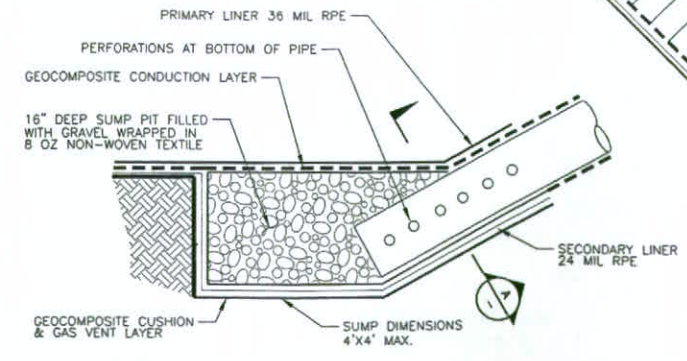
