PLEASE NOTE THAT THIS LOCATION WAS PREVIOUSLY PERMITTED UNDER OLD RULES BUT LOCATION HAS NOT BEEN BUILT YET SO WE ARE SUBMITTING THIS 2A AS PART OF REFILE PROCESS. Distance to nearest building, public road, above ground utility, railroad and surface water is greater than 5280' from proposed location. Depth to ground water determined by using static water level data from 3rd closest water well (Permit #62466/Receipt #9064975) because 1st and 2nd closest water wells did not have static water level data available.
