Monitoring well to the south of the Wastewater Treatment Plant (permit #261555, 37' total depth) is reported to be an artesian well with a static water level of 1.5 ft above ground surface. Water well to S.W. of location (permit #45846) with a total depth of 30 ft is reported to have a static water level of 10 ft below ground surface.
