The initial release at this site occurred in February 2006 (COGCC Remediation No. 3785).		
In December 2009, field crews were completing battery upgrades and discovered historical petroleum hydrocarbon impacted soil while removing the water sumps.		

CORRECTIVE ACTION

Describe immediate response (how stopped, contained and recovered): The wells were shut in and petroleum hydrocarbon impacted soil is being excavated. Groundwater was encountered in the excavation at approximately 6' bgs. Impact to groundwater was confirmed by the laboratory report on December 23, 2009 at which time the release became State reportable.


