The 2' distance to nearest surface water is referring to a stream that appears on the topo but that is not visible at the drillsite. There is a pond/windmill that is approx 3500' SW of proposed location. Distance to nearest railroad is over 1 mile from proposed location. Depth to groundwater determined by using static water level data from nearest water well (Permit#86114). Reference Area is adjacent to and south of well pad. Battery will be approx 1320 feet west/southwest of drillsite (located near Norris Unit C2 well).
