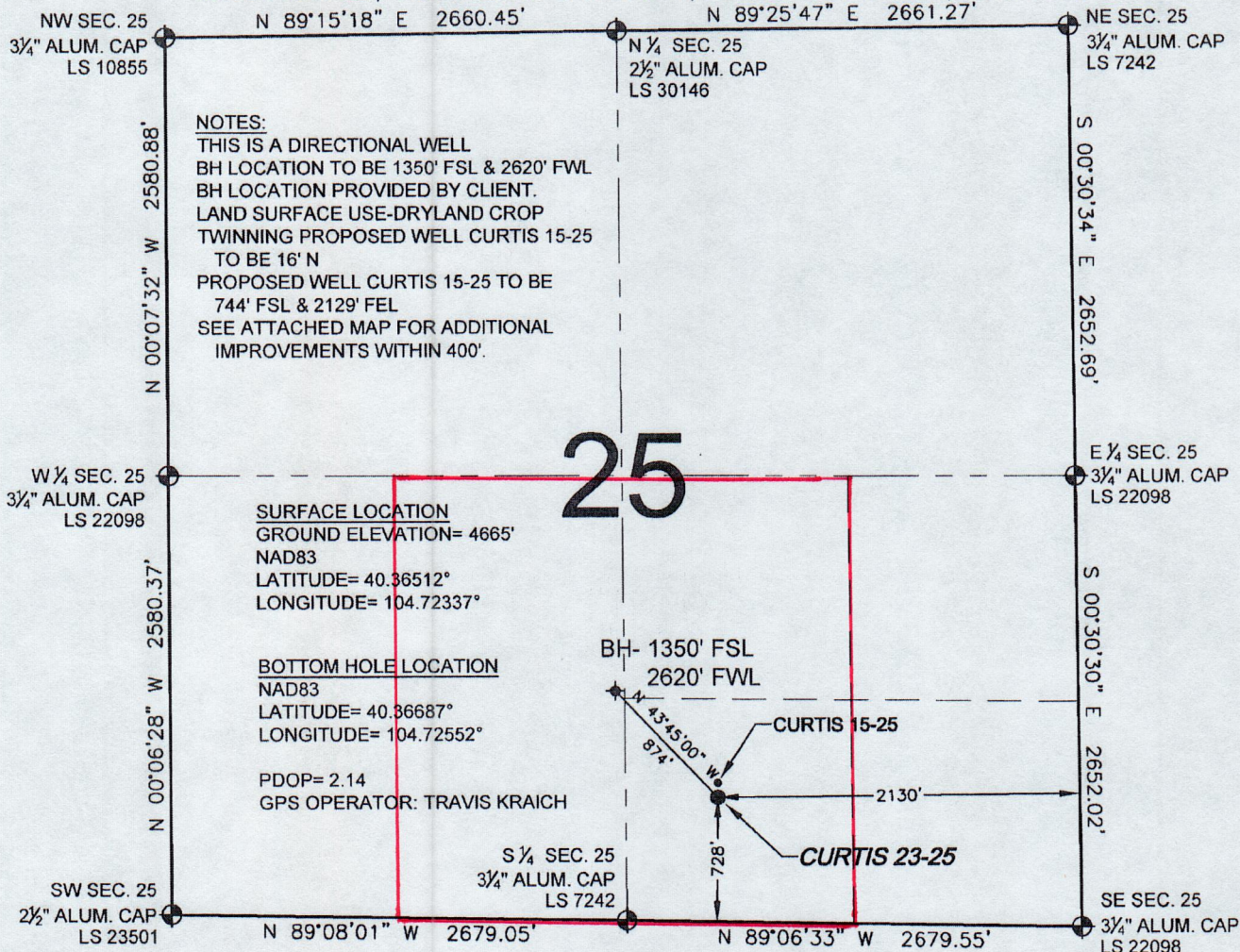

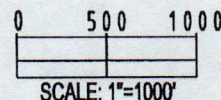
WELL LOCATION CERTIFICATE: CURTIS 23-25

● = PROPOSED WELL ◆ = EXISTING WELL

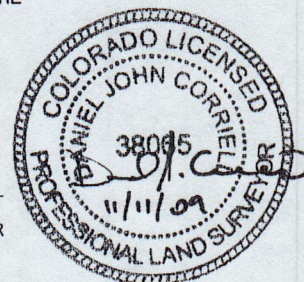

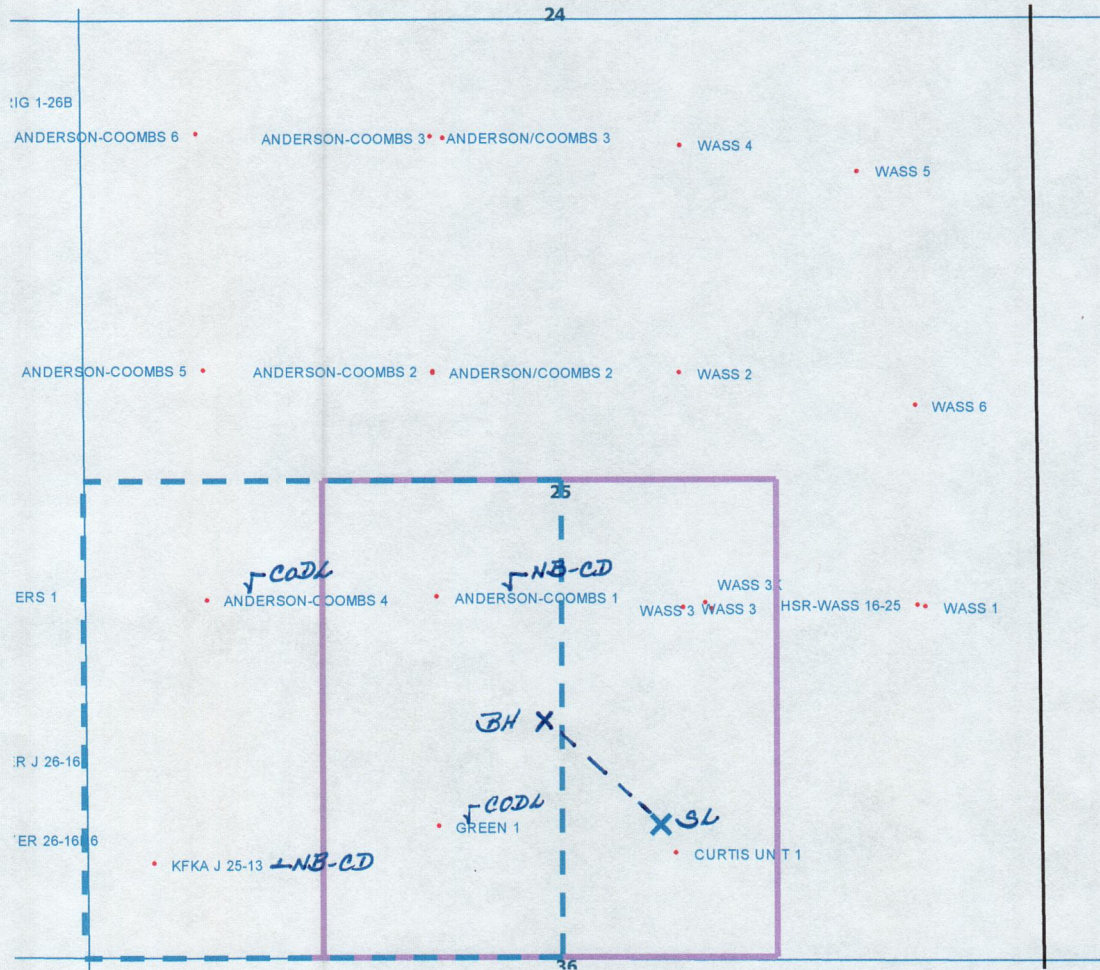
