THERE ARE NO CULTURAL/NATURAL RESOURCE FEATURES WITHIN 400' OF THIS PROPOSED LOCATION. ATTACHMENT A TO THE WELL LOCATION MAP GIVES A MORE DETAILED SITE DESCRIPTION OF THE OFFSET WELLS ON THE PAD. THE ROAD ACCESS MAP INDICATES THAT ACCESS TO THE TANK BATTERY IS ACTUALLY ON PHILLIP CAMENISCH'S LAND (SHARED ACCESS TO CAMENISCH TANK BATTERY) AND TANK BATTERY IS AT A REMOVE FROM THE PROPOSED WELLHEAD LOCATION.
