Janni,

I have been reviewing the Grassy OM I33 595, 09B I33 595 (#400024086) **Form 2A**. COGCC requests the following clarifications regarding the data Berry Petroleum has submitted on or attached to the Form 2A prior to passing the Oil and Gas Location Assessment.

1. **Water Resources (Section 14):** Form 2A indicates that the distance to the nearest water well is 150 feet to the south with a depth to groundwater of 55 feet bgs. COGCC's review did not find this well in the state's database information. If you could confirm what type of water well this is (monitoring, domestic, stock, industrial, etc.) and the owner, I would appreciate it.
2. **Notice to Operators (NTO) Drilling Wells on the Roan Plateau in Garfield County:** Comply with all provisions of the June 12, 2008 Notice to Operators (NTO) Drilling Wells Within  $\frac{3}{4}$  Mile of the Rim of the Roan Plateau in Garfield County – Pit Design, Construction, and Monitoring Requirements. At a minimum, the following condition of approval (COA) will apply:

COA 6 - All pits must be lined.

COGCC would appreciate your concurrence with attaching this COA to the Form 2A permit prior to passing the OGLA review. The other issue also needs to be addressed prior to getting this permit passed.
