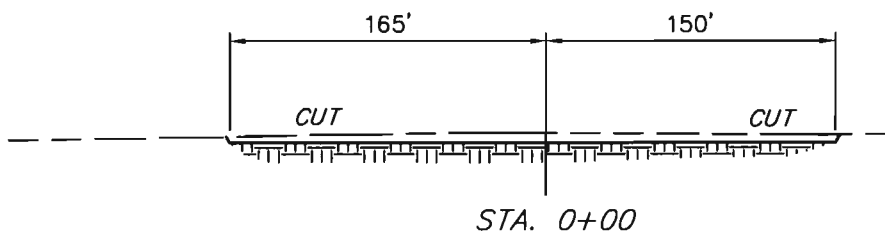

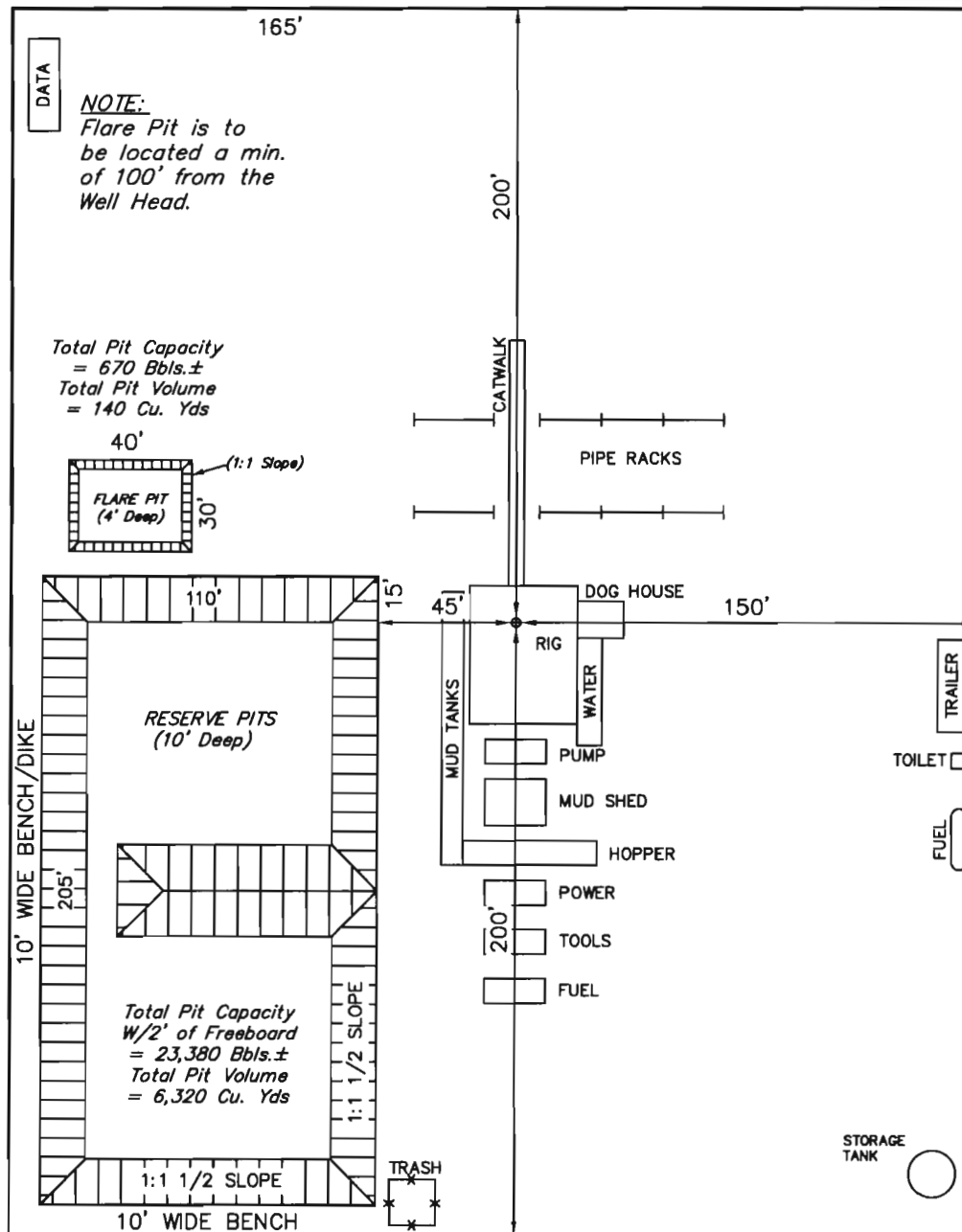

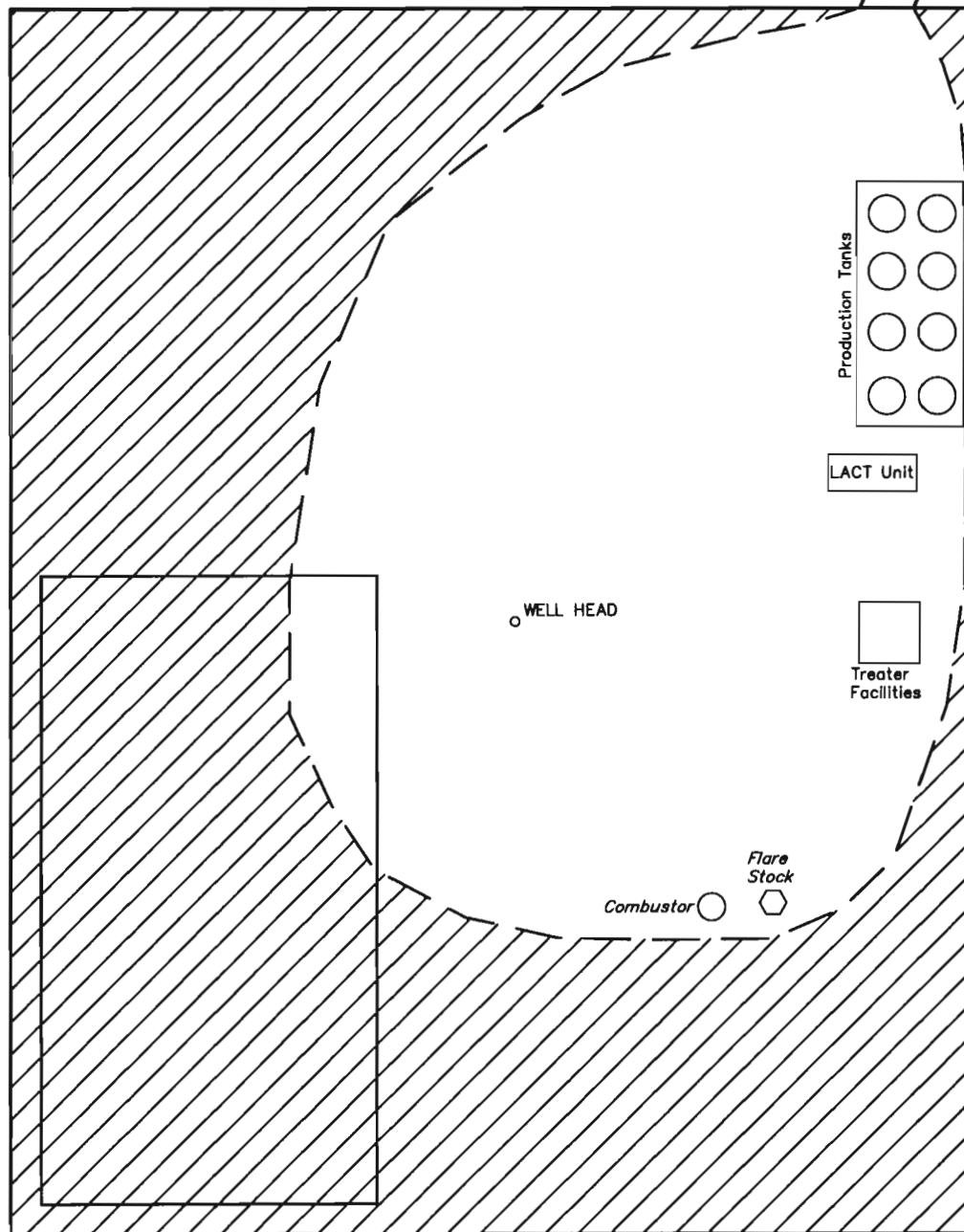

UN-RECLAIMED AREA =  $\pm 1.271$  ACRES



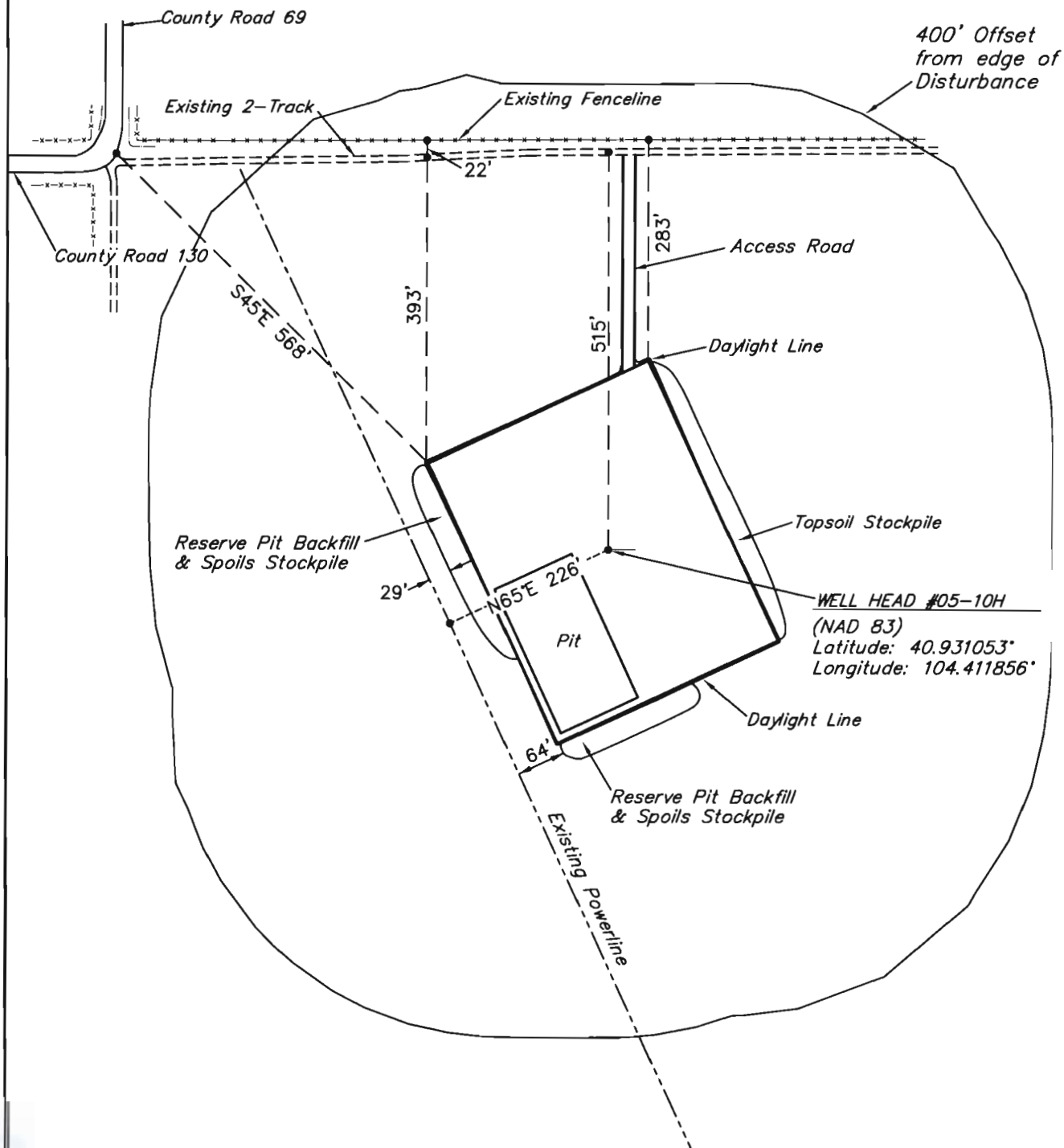
RE-HABED AREA

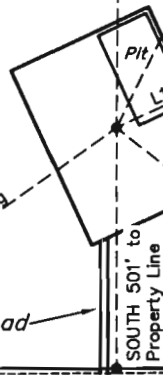
