SEC. 14. WATER RESOURCES: NEAREST WATER WELL SUPPOSEDLY LOCATED 46' FROM PROPOSED LOCATION, REF. PERMIT 1353-AD-PERMIT DENIED-A WELL DOES NOT EXIST. DEPTH TO GROUNDWATER: REF. PERMIT 13964-R-R AS THE NEXT CLOSEST WATER WELL (APPROXIMATELY 2560' SE) OF PROPOSED LOCATION. HOWEVER, THIS WATER WELL IS LOCATED IN A LOWER LYING AREA AT APPROXIMATELY 4930' ELEVATION WITH AN 11' DEPTH TO GROUND WATER. THE PROPOSED LOCATION IS LOCATED AT A HIGHER ELEVATION OF 4951'. DUE TO ELEVATION DIFFERENCES, THIS PROPOSED LOCATION IS NOT CONSIDERED A SENSITIVE AREA.
