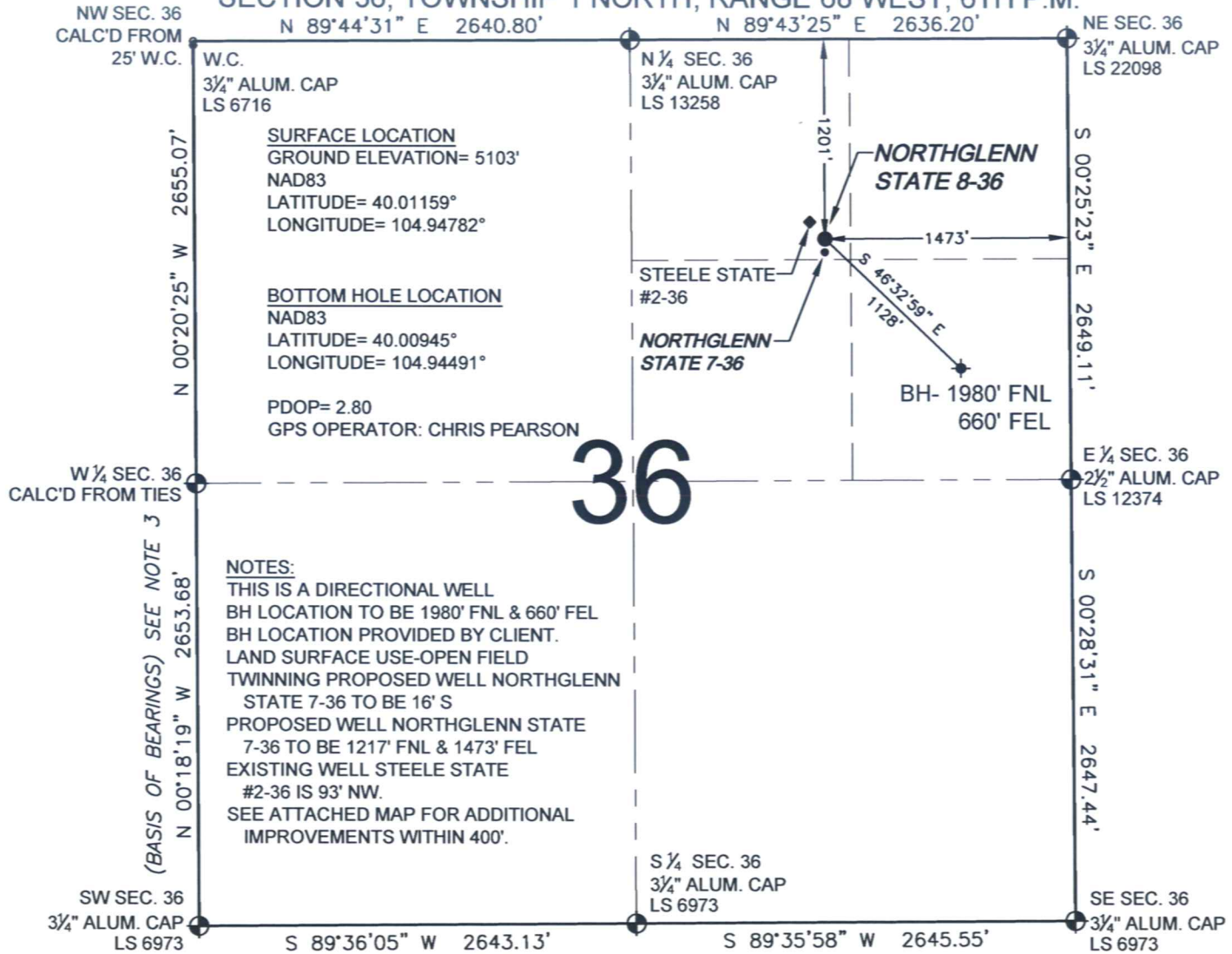


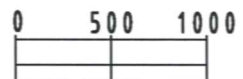
WELL LOCATION CERTIFICATE: NORTHGLENN STATE 8-36

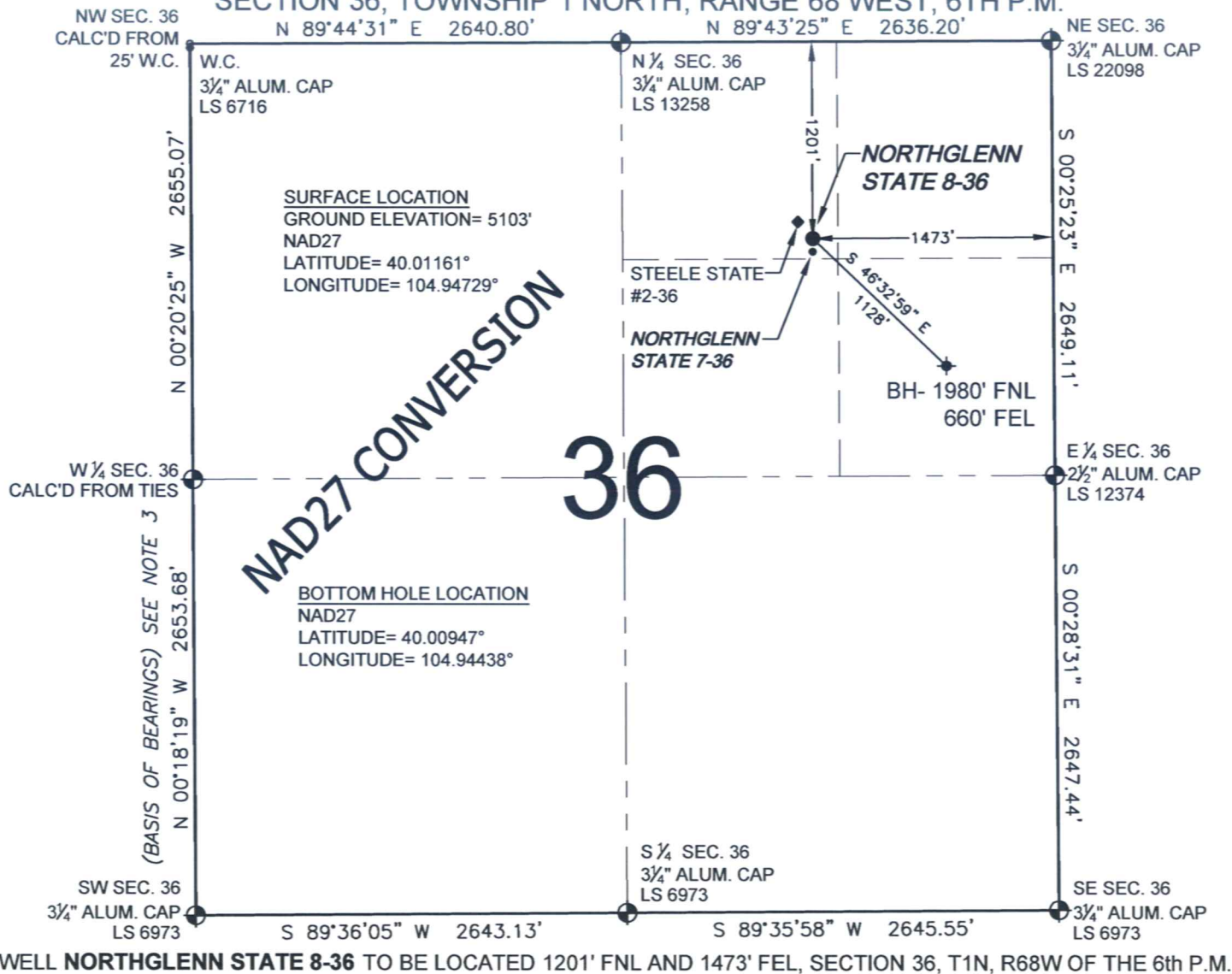

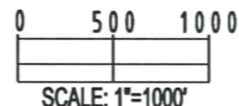
