THIS LOCATION IS IN A SENSITIVE AREA DUE TO BEING WITHIN THE NORTHERN HIGH PLAINS DESIGNATED BASIN. NO COAs ARE NEEDED FOR THIS LOCATION. THERE IS AN EPHEMERAL STREAM APPROXIMATELY 30 FEET, MORE OR LESS, SOUTH OF SITE. A PUMP JACK MAYBE NECESSARY TO PLACE ON FACILITY IN THE FUTURE TO HELP WITH GAS PRODUCTION. IT WILL REQUIRE EITHER ONE GAS OR ONE ELECTRIC MOTOR TO RUN THE PUMPING JACK UNIT.
