The well pad has been constructed, there are no producing wells on this location; there is currently no drilling rig on this pad. Drilling operations are projected to commence sometime in 2010. The well pad will not need to be altered. A semi-closed loop system will be used. Per GarCo Vacation Ordinance dated 10-5-1987, CR 213 is now OXY's private property north of Sec 8, 7S, 97W, 6 PM. Oxy will comply with new "Notice to Operators" regarding reserve pits (June 12, 2008). Oxy has another well by the same name under API 05-045-18373; 05-045-18373 will be withdrawn.
