All representations, stipulations and conditions of approval stated in this Form 2A for this location shall constitute representations, stipulations and conditions of approval for any and all subsequent operations on the location unless this Form 2A is modified by Sundry Notice, Form 4 or an Amended Form 2A.

Location is in a sensitive area because of close proximity to surface water, therefore, operator must ensure 110 percent secondary containment for any volume of fluids contained at well site during drilling and completion operations.

Operator must implement best management practices to contain any unintentional release of fluids.

To the extent practicable, the operator shall preserve the trees between the proposed location and Las Animas County Road 43.5 while at the same time minimizing disturbance to land that the surface owner utilizes for hay production

Location is in a sensitive area because of proximity to domestic water well, surface water and wetlands; therefore, either a lined drilling pit or closed loop system is required.

Location is in a sensitive area because of proximity to a domestic water well and potential for adverse impacts to groundwater; therefore all pits should be lined
