THIS LOCATION ASSESSMENT IS FOR THE PA 21-9 WELL PAD. THERE WILL BE A TOTAL OF 15 WELLS ON THE PAD WHEN DRILLED OUT. THERE IS CURRENTLY AN APPROVED APD FOR THE PA 522-9 WELL WHICH IS BEING RE-FILED AT THIS TIME DUE TO EXPIRATION. THE PAD WAS CONSTRUCTED UNDER THIS APD. WE ARE PERMITTING AN ADDITIONL 3 WELLS AT THIS TIME FOR A TOTAL OF 4 TO BE DRILLED AT THIS VISIT. THE PAD AND PITS ARE BUILT IN ACCORDANCE WITH LAYOUT ON PLAT 2 CONSTRUCTION LAYOUT AND NO EXPANSION WILL BE NEEDED. CONDUCTORS HAVE BEEN SET. PAD IS RIG READY. SURFACE AND MINERALS ARE OWNED IN FEE. THE LOCATION REFERENCE POINT FOR THIS FACILITY IS THE PROPOSED PA 21-9 WELL. ALL MEASUREMENTS WERE TAKEN FROM THIS POINT. REFERENCE PHOTOS WILL BE PROVIDED AT A LATER DATE DUE TO SNOW ON GROUND.

**All representations, stipulations and conditions of approval stated in this Form 2A for this location shall constitute representations, stipulations and conditions of approval for any and all subsequent operations on the location unless this Form 2A is modified by Sundry Notice, Form 4 or an Amended Form 2A.**

No portion of any pit that will be used to hold liquids shall be constructed on fill material, unless the pit and fill slope are designed and certified by a professional engineer, subject to review and approval by the director prior to construction of the pit. The construction and lining of the pit shall be supervised by a professional engineer or their agent. The entire base of the pit must be in cut.

Operator must implement best management practices to contain any unintentional release of fluids.

The moisture content of any drill cuttings in a cuttings pit, trench, or pile shall be as low as practicable to prevent accumulation of liquids greater than de minimis amounts. At the time of closure, the drill cuttings must also meet the applicable standards of table 910-1.

Location is in close surface water; therefore, operator must ensure 110 percent secondary containment for any volume of fluids contained at well site during drilling and completion operations.
