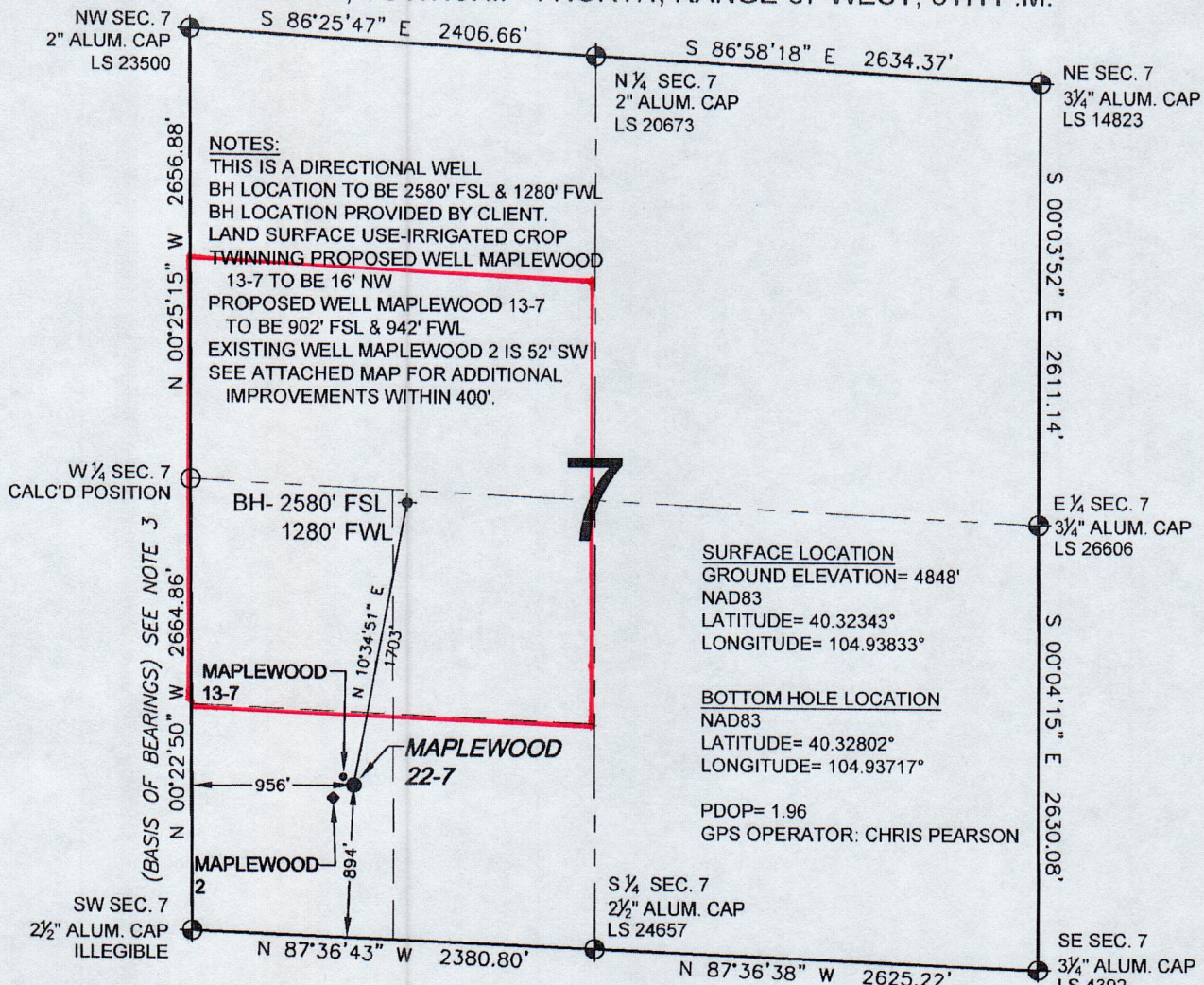

WELL LOCATION CERTIFICATE: MAPLEWOOD 22-7

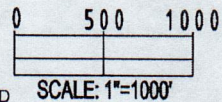

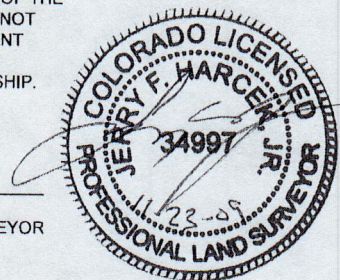

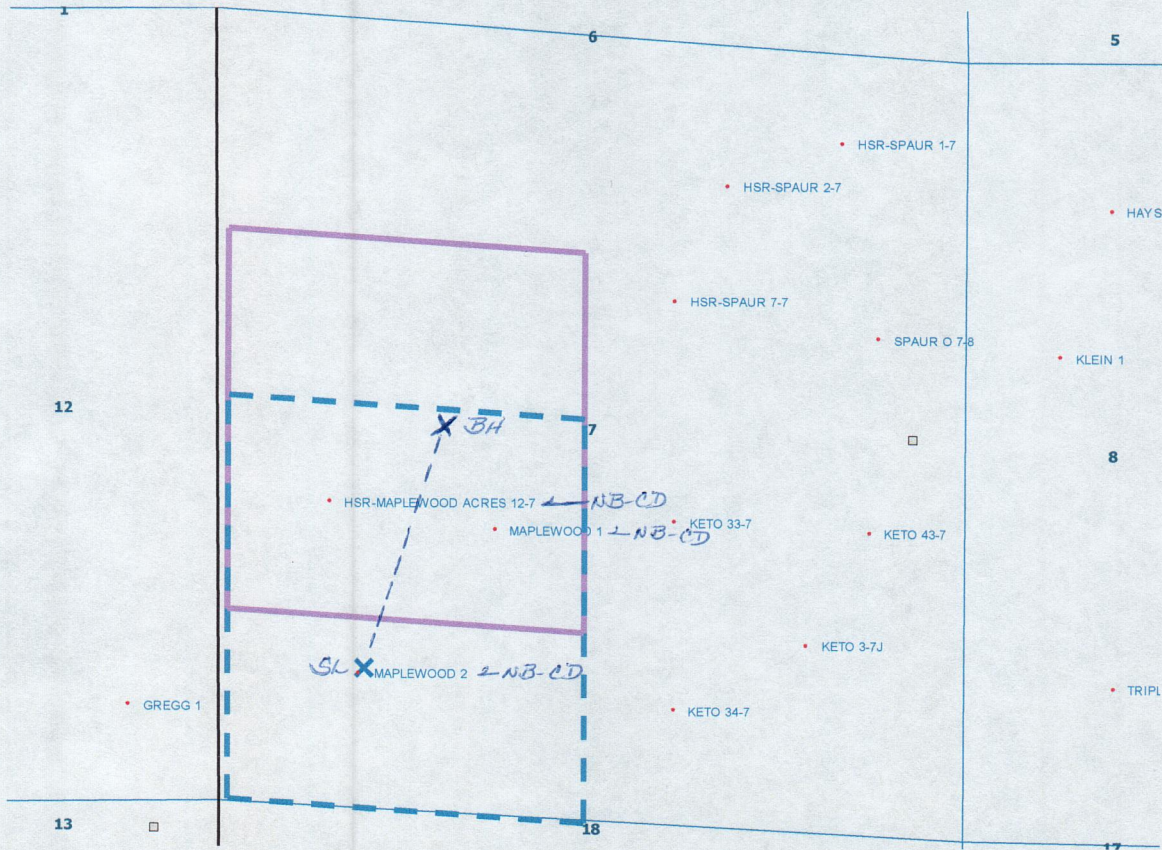
