The well pad will not need to be altered. A semi-closed loop system will be used. Per GarCo Vacation Ordinance dated 10-5-1987, CR 213 is now OXY's private property north of Sec 8, 7S, 97W, 6 PM. Oxy will comply with new "Notice to Operators" regarding reserve pits (June 12, 2008). Oxy has another well by the same well name of Cascade Creek 697-17-15 permitted with API 05-045-18379; API 05-045-18379 will be withdrawn.
