- Plat illustrating proposed wellbore spacing unit on existing location plat.



Bottom Hole Located SWNW, Sec. 17, T3N-R65W



Noble Energy, Inc. ("Noble") intends to propose, drill and operate the referenced well pursuant to paragraph 6 of Rule 318A.e., Order 1R-100 of the Colorado Oil and Gas Conservation Commission ("COGCC"). Attached for your information is a plat representing this proposal.

Additional information for this well:

- (1) **Wellbore Spacing Unit**
The wellbore spacing unit will be comprised of the SE/4NE/4, NE/4SE/4 of Section 18, in T3N, R65W, 6th P.M., and the SW/4NW/4, NW/4SW/4 of Section 17, in T3N, R65W, 6th P.M., as depicted on the enclosed plat. 


