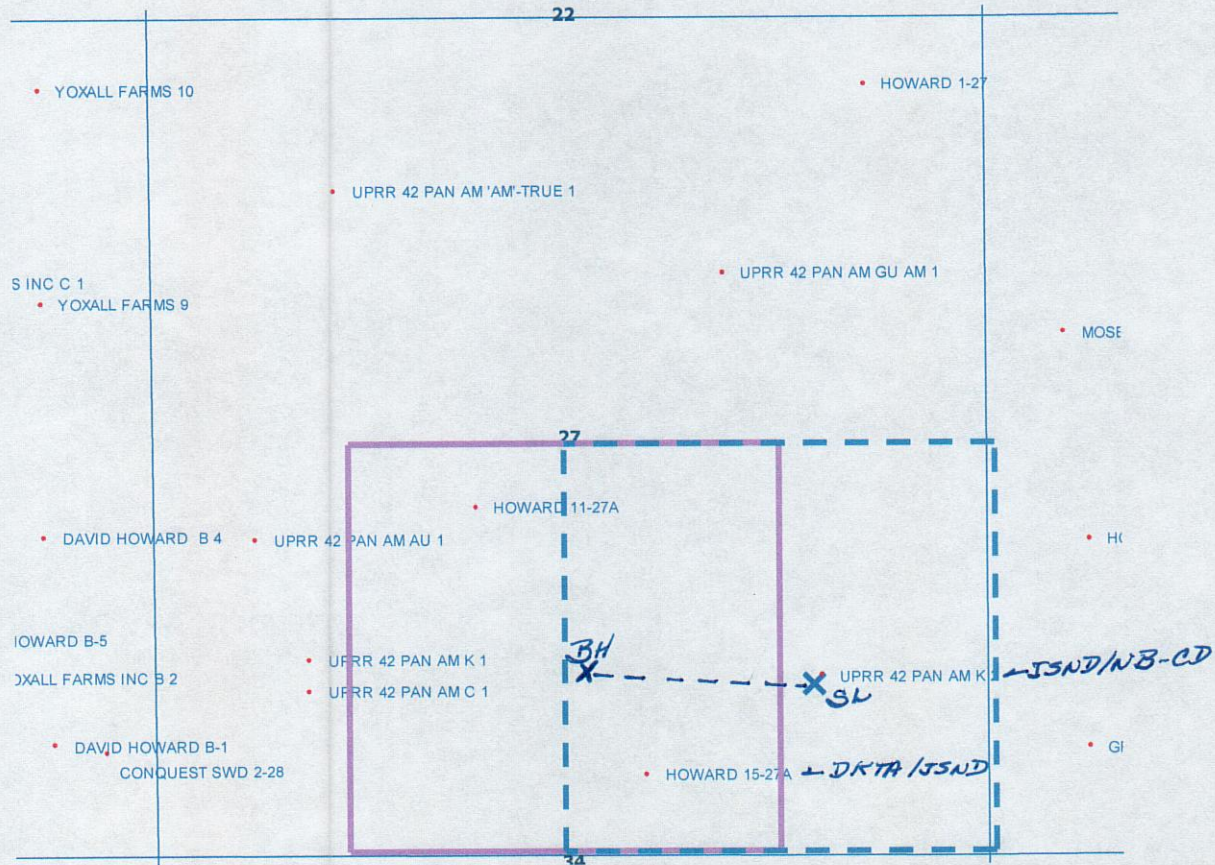

Proposed 160 acre Spacing Unit (Solid line).



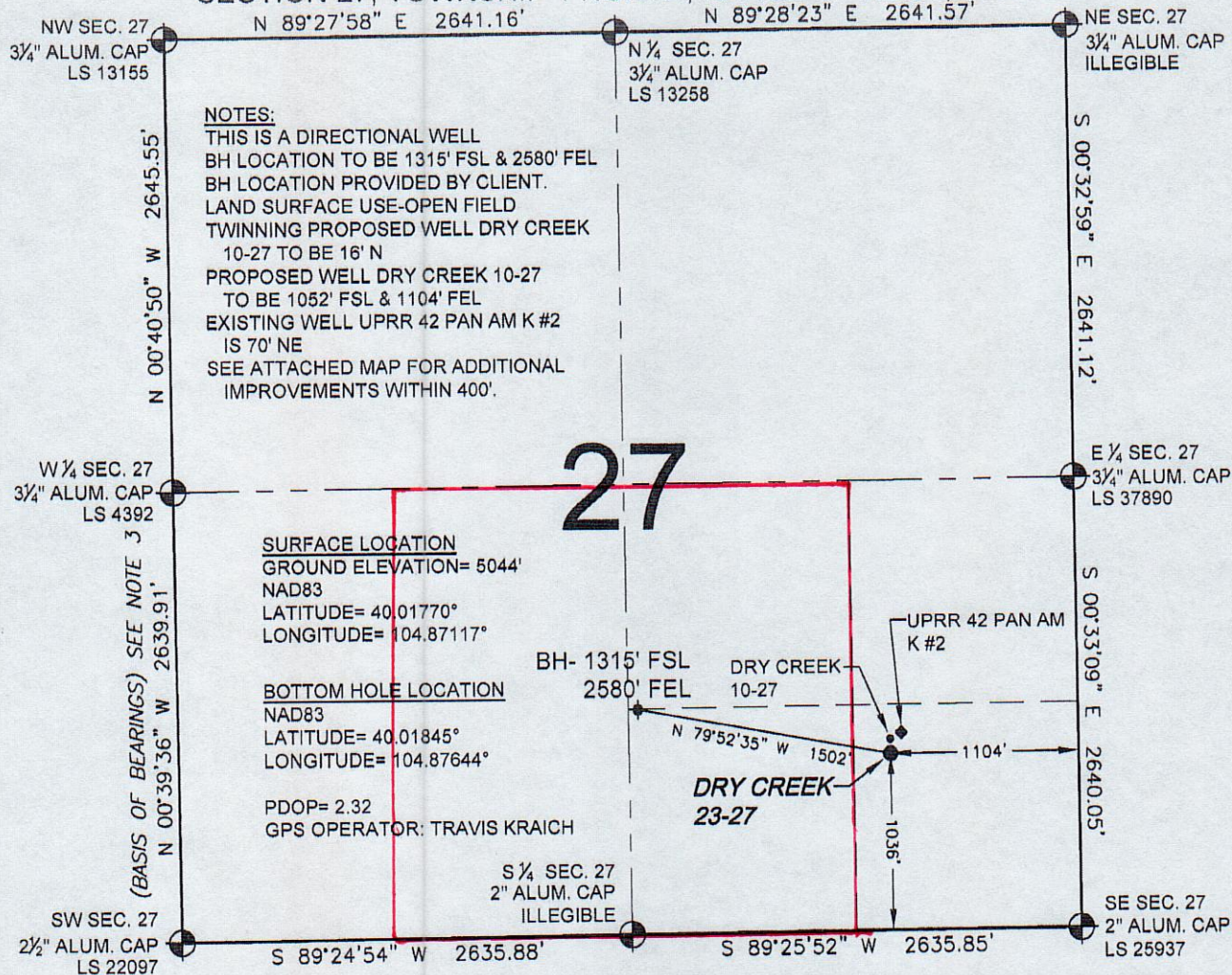
Bottom Hole Located SW/4SE/4, Sec. 27-T1N-R67W (Dashed line).

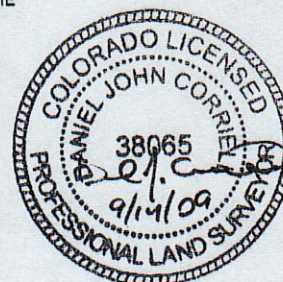
