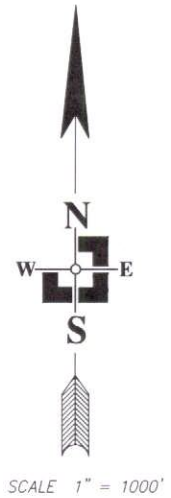
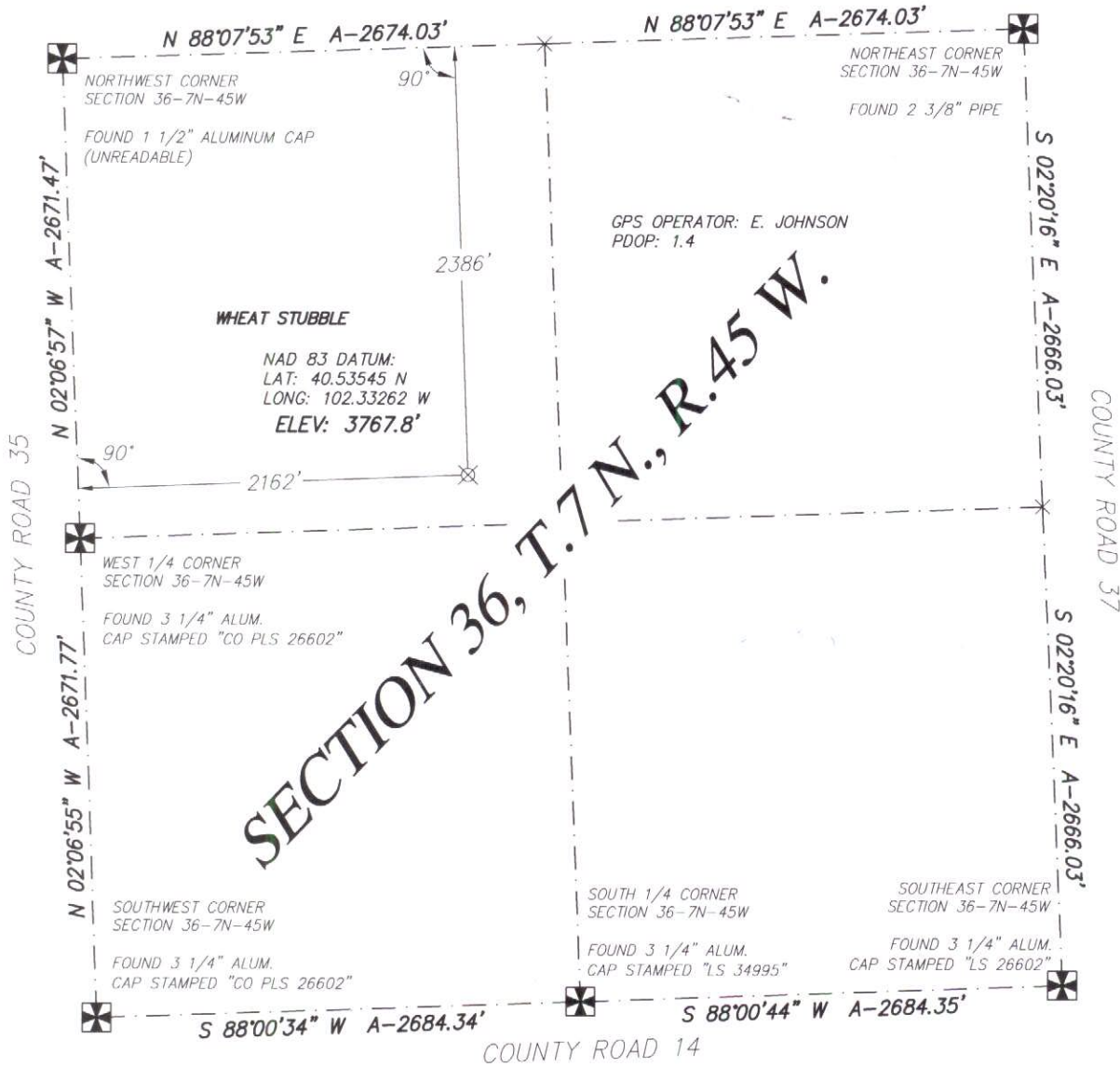

THIS LOCATION MAY BE DESCRIBED AS A POINT 2386 FEET SOUTH OF THE NORTH LINE AND 2162 FEET EAST OF THE WEST LINE OF SECTION 36, TOWNSHIP 7 NORTH, RANGE 45 WEST OF THE 6TH P.M., PHILLIPS COUNTY, COLORADO.**
