Railroad is over 1 mile away. There are no visible improvements within 400'. The nearest water well is 2,438 +/- feet away. This location is in a sensitive area due to being within the Northern High Plains designated basin. No COAs are needed for this location. A Pump Jack maybe necessary to place on facility in the future to help with gas production. It will require either one gas motor OR one electric motor to run the pumping jack unit which will be chosen IF its needed at that time.
