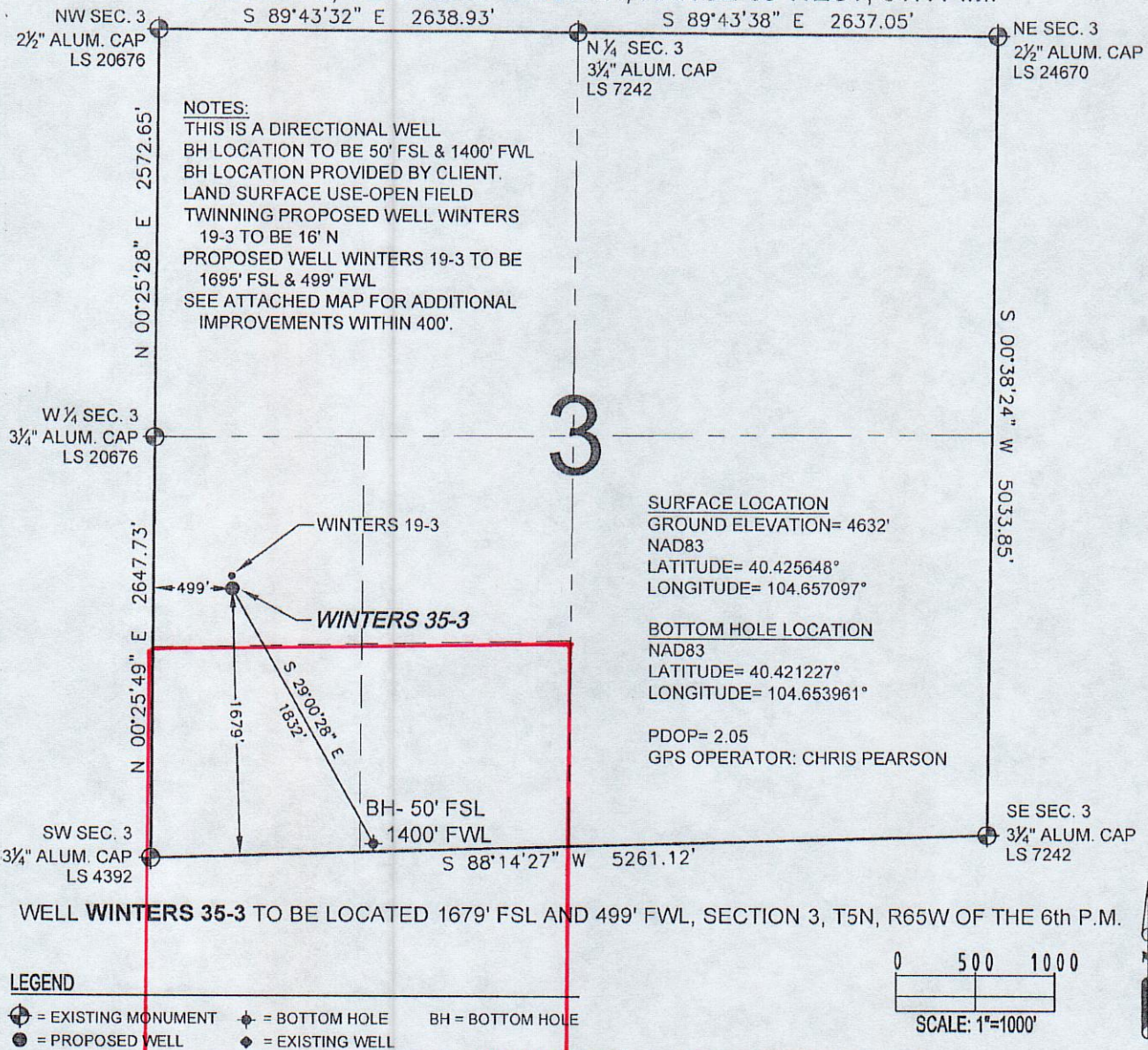

SECTION 3, TOWNSHIP 5 NORTH, RANGE 65 WEST, 6TH P.M.

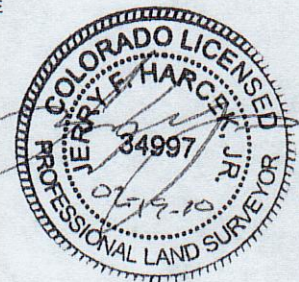

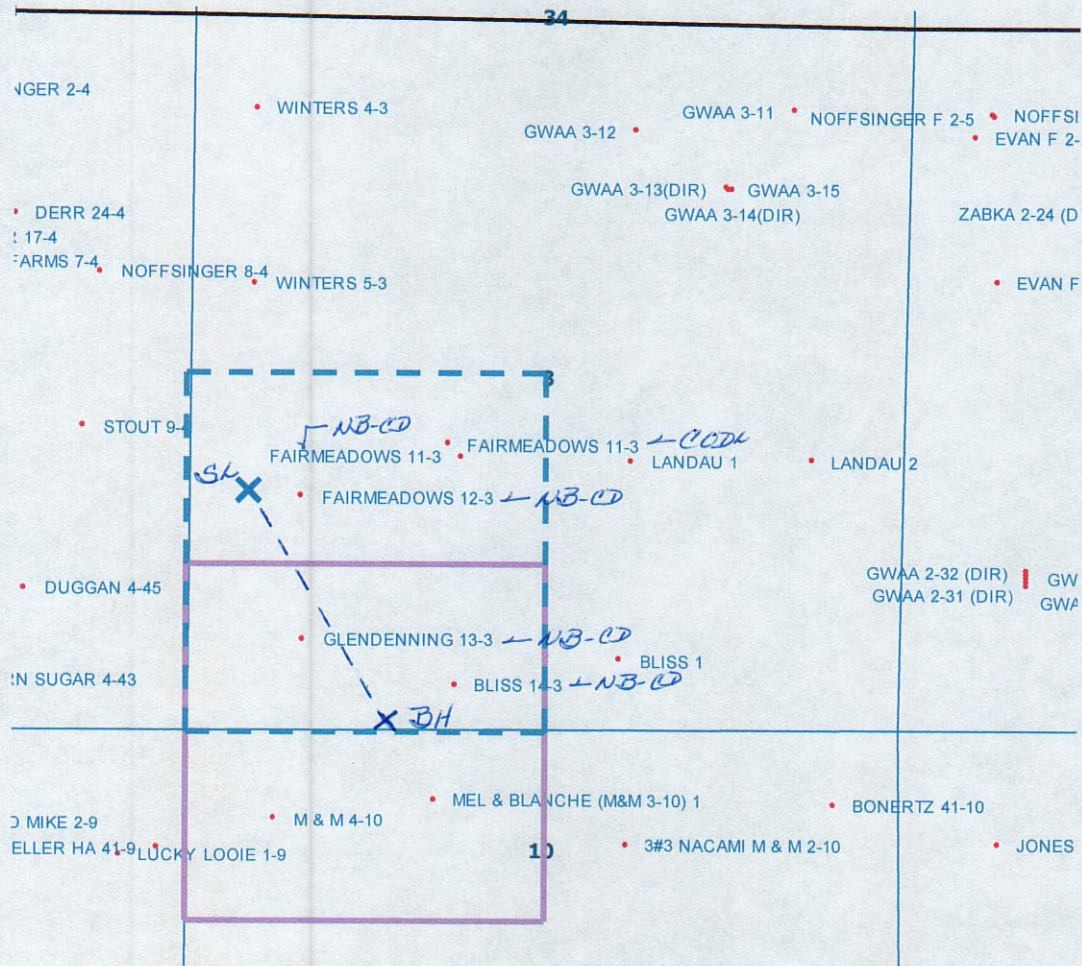
