#4 – GPS Data: No PDOP reading is available as per Surveyor - Control for survey was established using differentially corrected GPS from an Opus based control network. Well location was established using non-GPS conventional methods, therefore no PDOP reading was taken. #6 - Construction - Delta Petroleum used well BCU 16-433 as the point to determine distance from wellhead. #14 - Water Resources - The depth to ground water was determined by using static water level data of nearest waterwell (Permit # 280720/ Receipt # 9503230). The reference area is undisturbed ground immediately adjacent and south of the pad as shown in "Looking South" location photos. #9 – Cultural - All distances listed as 5280 are over 1 mile.

CONDITIONS OF APPROVAL, IF ANY:

All representations, stipulations and conditions of approval stated in this Form 2A for this location shall constitute representations, stipulations and conditions of approval for any and all subsequent operations on the location unless this Form 2A is modified by Sundry Notice, Form 4 or an Amended Form 2A.

Location is in a sensitive area because of close proximity to surface water, therefore, operator must ensure 110 percent secondary containment for any volume of fluids contained at well site during drilling and completion operations.

The moisture content of any drill cuttings in a cuttings pit, trench, or pile shall be as low as practicable to prevent accumulation of liquids greater than de minimis amounts. At the time of closure, the drill cuttings must also meet the applicable standards of table 910-1.

Operator must implement best management practices to contain any unintentional release of fluids.

Location is in a sensitive area because of shallow groundwater; therefore, either a lined drilling pit or closed loop system must be implemented.
