We believe the water well shown in the center of the SWSE is a "canned" location. I have spoken to the farmer who farmed this farm for years and he indicates there is not a well there as indicated on the COGCC map. The closest well is in the extreme SWSE next to the farmhouse (667" away). The depth to ground water indicated on the #14 question has been confirmed by the farmer/owner who has farmed this parcel for many years. \*Question #9 Cultural-the 2 next to railroad refers to 2.81 miles\*
