RAILROAD IS 4.5 MILES +/- AWAY. NO VISIBLE IMPROVEMENTS WITHIN 400' RADIUS OF SITE. NEAREST WATER WELL IS 5271' +/- AWAY (RECEIPT: 0452376B; PERMIT NO.: 221503-A; USE DOMESTIC STOCK0. THERE IS A DRY INTERMITTENT STREAM LOCATED 1,368' +/- OF WELL SITE. THIS LOCATION IS IN A SENSITIVE AREA DUE TO BEING WITHIN THE NORTHERN HIGH PLAINS DESIGNATED BASIN. NO COAS ARE NEEDED FOR THIS LOCATION. A PUMP JACK MAY BE NECESSARY TO PLACE ON FACILITY IN THE FUTURE TO HELP WITH GAS PRODUCTION. IT WILL REQUIRE EITHER ONE GAS MOTOR TO RUN THE PUMPING JACK UNIT.
