I spoke with our biologists yesterday afternoon. No owls or other sensitive/threatened/endangered species are present at the Deep Canyon location.

Therefore, the monitor well construction and reclamation activities can begin anytime after today. Thanks for your patience on this matter.

When you determine the actual date you will begin mobilizing equipment, please let me know so I can notify the appropriate people in my organization.

I have attached the FS permit Conditions of Approval to remind us all. They are the same as the ones used for the 2008 activities. Because of your past (excellent) track record, many of the coordination and design inspection requirements can be achieved with phone calls and emails. There is some sensitivity to this project because of the close proximity to the drainage, the Southern Ute Indian Reservation, and the Pagosa Ranger District (I work on the Columbine Ranger District, so I/we are on my neighbors land with their permission), so please keep me posted on project status on at least a weekly basis. If anything out of the ordinary occurs, please notify me as soon as possible.
