- Plat illustrating proposed wellbore spacing unit on existing location plat.

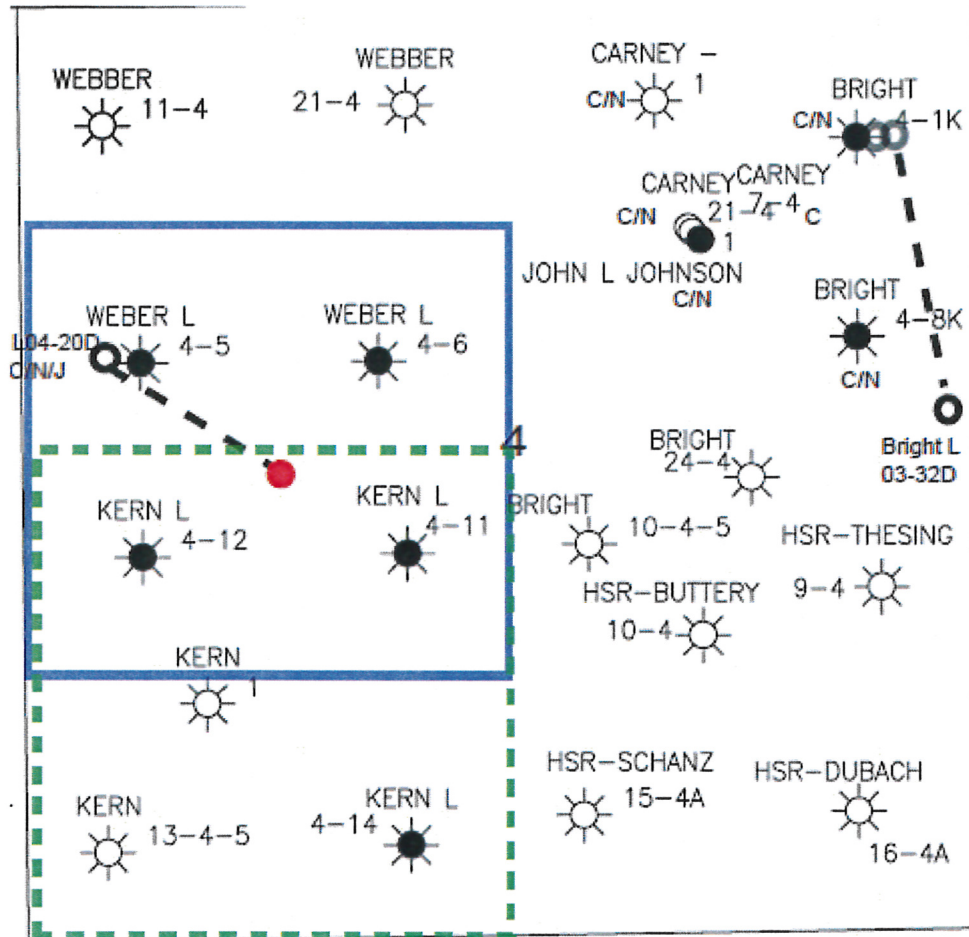
Thank you for your attention to the enclosed. NEI respectfully requests that the COGCC review the enclosed information and approve the Application for Permit to Drill the captioned well.

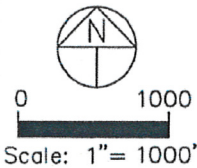
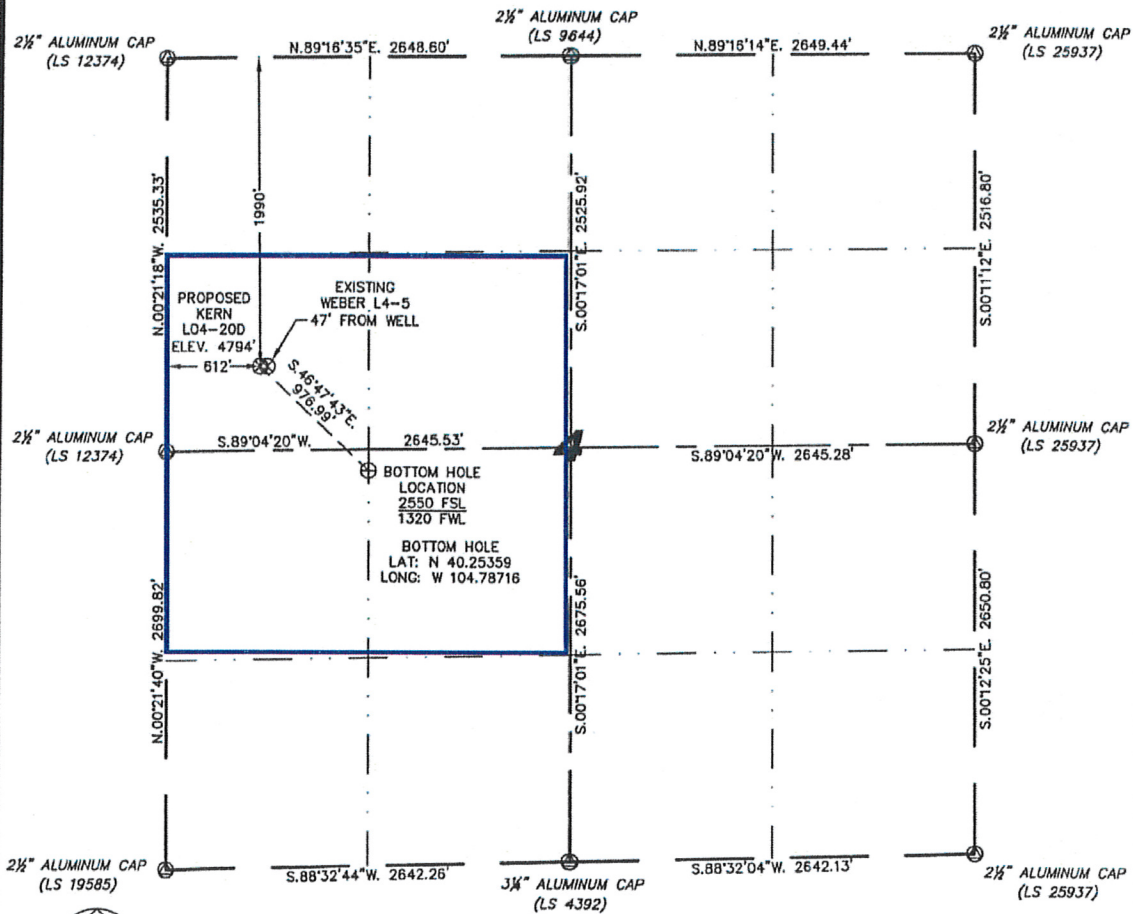

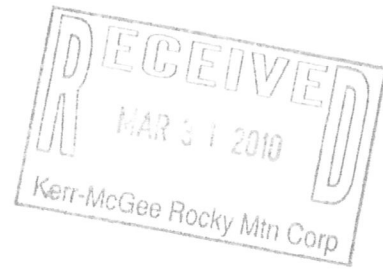

Noble Energy, Inc. ("Noble") intends to propose, drill and operate the referenced well pursuant to paragraph 6 of Rule 318A.e., Order 1R-100 of the Colorado Oil and Gas Conservation Commission ("COGCC"). Attached for your information is a plat representing this proposal.

Additional information for this well:

- (1) **Wellbore Spacing Unit**  
The wellbore spacing unit will be comprised of the S/2NW/4 of Section 4, in T3N, R66W, 6<sup>th</sup> P.M., the N/2SW/4 of Section 4 in T3N, R66W, 6<sup>th</sup> P.M., and the W/2 of Section 4 in T3N, R66W, 6<sup>th</sup> P.M., as depicted on the enclosed plat. The working interests attributable to the Codell/Niobrara/J Sand formations in the contributing 40 acre quarter-quarter sections will be utilized to determine the interests of the parties in the proposed 160 acre spacing unit, for the Codell/Niobrara formation, and proposed 320 acre spacing unit, for the J Sand formation, of this well. It appears that you own a working interest in the proposed wellbore spacing units for this well.
- (2) **Target Formations**  
This well will be drilled to a total depth to sufficiently test the Codell/Niobrara/J Sand formations.
