


# WELL LOCATION CERTIFICATE


THIS MAP DOES NOT REPRESENT A BOUNDARY SURVEY

King Surveyors Inc. has determined the surface location of the SEKICH P19-21D to be 2614' from the SOUTH line and 2191' from the EAST line and the bottom hole to be 2550' from the SOUTH line and 2525' from the EAST line as measured at right angles from the section line of Section 19, Township 3 North, Range 67 West of the Sixth Principal Meridian, County of Weld, State of Colorado.




