33. Comments #14 – GPS Data: No PDOP reading is available as per Surveyor - Control for survey was established using differentially corrected GPS from an Opus based control network. Well location was established using non-GPS conventional methods, therefore no PDOP reading was taken. Casing plan – Production casing top of cement will be > 500' above top of gas. Delta Petroleum is the surface owner, therefore Rule 306 is not applicable. There will not be a 30 day letter or SUA attached. I certify that all conditions in the original permit are the same, except distance to property line, which has been updated since Delta became surface owner. There have been no changes to land use or well construction. Pad BCU 14L is an existing pad. Pad expansion is required, COGCC Form 2A is including in permit package.
