- (2) The Federal RG 32-14-198 is an existing location. Pad will be expanded as shown in construction drawings
- (3) Item 14, water level of nearest drilled water well (stock well SWNW Sec 12, T2S-R98W. Permit #4830--) shows static water level of 50'
- (4) Construction Layout Plan slot list identifies 22 slots, 3 of which are opened and not planned for drilling. There are 3 producing wells on location (Federal RG 32-,21-,31-14-298). The 15 new locations will be drilled in one visit, after which the pad will be put into interim reclamation. One additional location (Federal RG 621-14-298) will be permitted and drilled at a later date. There is also one abandoned permit associated with this pad (RGF 313-14-2-98).
- (5) The following 15 APD's are associated with this 2A application: Federal RG 333-,633-,532-,432-,332-,531-,431-,331-,522-,422-,22-,322-,521-,421-, 321-14-298.
- (6) Reclamation reference area is immediately adjacent to the location.
