Conductor pipe and lined drilling pit will be used in construction of this well location. Will bond on to drill this well, as there is no executed SUA with surface owner. Static water level of 10' BS in water well bearing west at 85'. Existing facility for Kammerzell #1-9 and #7-4 footprint will be minimally impacted as production has dropped off and ne new tanks will be needed. The separator for this well will fit within the footprint already existing for the separators on the facility location. The existing tank battery facility will service the Kammerzell #1-9 (API#05-123-11436), Kammerzell #7-4 (API#05-123-22643), Kammerzell #7-7-24, Kammerzell #17-7, and Kammerzell #8-7-41.
