This pad is built, however since we are modifying this pad from 6 wells to 14 wells, we are submitting this Form 2A as required by the new rules. The Reference Area is undisturbed ground immediately adjacent and to the North of the well pad, as shown in the "North" location photo. The depth to ground water was determined by using static water level data of Permit#109314/Receipt#0107044 which is approx 3500 feet SE of location, because there was no static water level data available for nearest water well.
