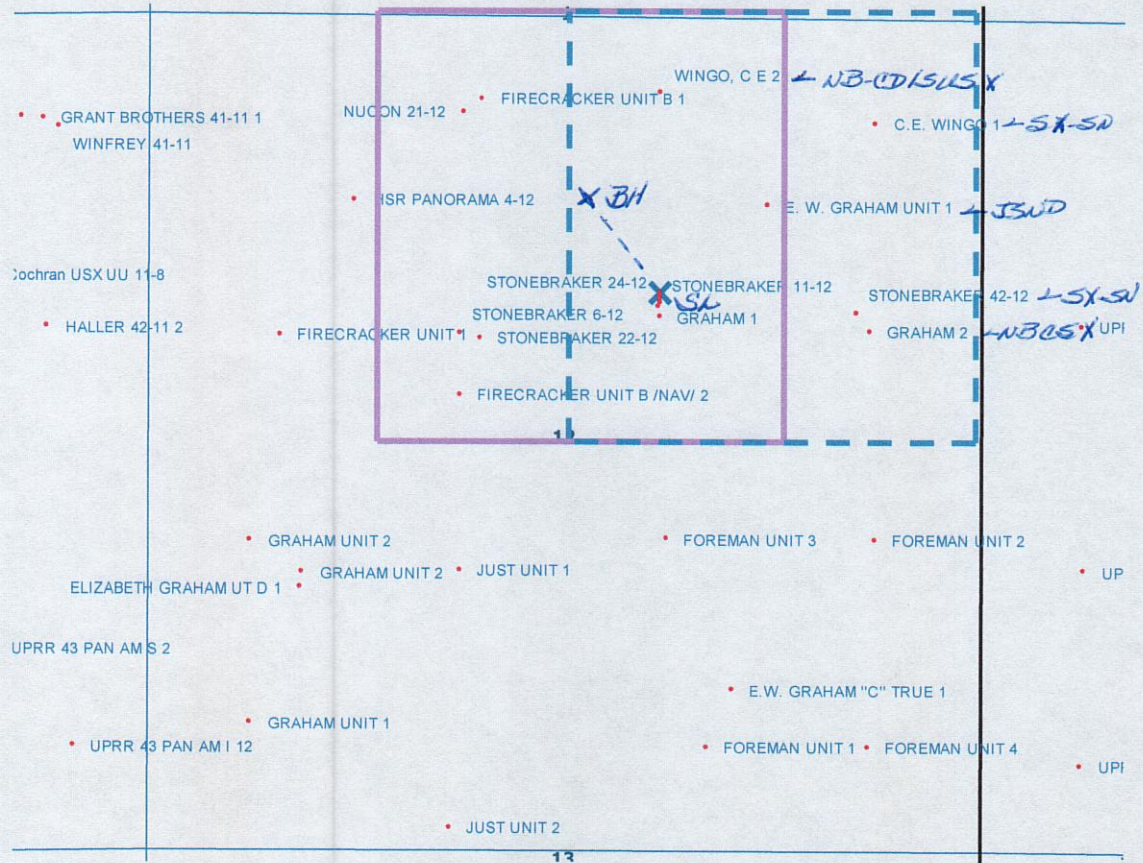

Proposed 160 acre Spacing Unit (Solid line).

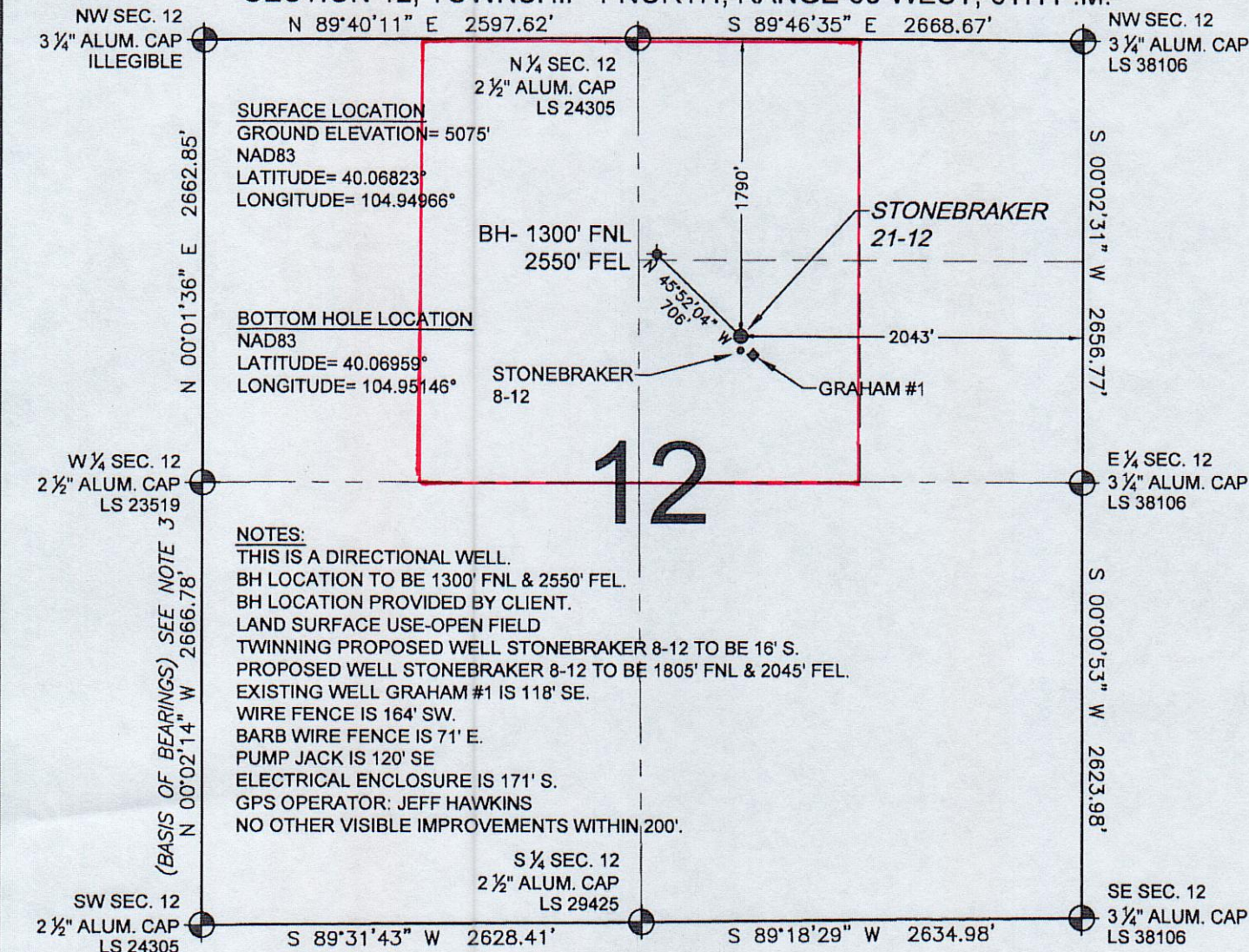


Bottom Hole Located NW/4NE/4, Sec. 12-T1N-R68W (Dashed line).

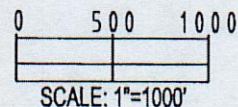

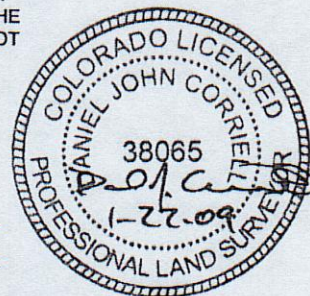
