The nearest railroad and overhead power lines are greater than 1 mile from proposed well pad. The reference area is on undisturbed ground immediately adjacent to the location to the East, as shown in the East location photo. The depth to ground water was determined by using the static water level data of the nearest water well (Permit #159655-A). Please note that the body of water shown on the hydrology map is actually a dry swale.
